
This waiver, authorized under the provisions of 1915(c) of the Social Security Act, will enable the State to provide home and community-based care to individuals with intellectual disabilities, which allows them to live more independently in their homes and communities, and to provide a variety of services that promote community living, including participant directed service models and traditional agency-based service models. The services that will be available through the waiver include the following: Education Support Services, Home and Community Habilitation (Unlicensed), Homemaker/Chore, Licensed Day Habilitation, Prevocational Services, Residential Habilitation, Respite, Supported Employment, Supports Coordination, Nursing, Therapy Services, Supports Broker Services, Assistive Technology, Behavioral Support, Companion Services, Home Accessibility Adaptations, Specialized Supplies, Transitional Work Services, Transportation, and Vehicle Accessibility Adaptations.
