

Below is the amount of Capital Funds HUD announced on 6/5/06 that your Housing Authority will receive. Next to the dollar amount we have calculated the number of fully accessible UFAS units the Housing Authority SHOULD have. That is, under Section 504 of the Rehabilitation Act, AT LEAST 5% of the Housing Authority's total number of units should be FULLY ACCESSIBLE and lived in by persons who have mobility impairments and who require UFAS mobility accessibility features. The number of units is the 5% bottom line.

As a disability advocate in your area, please make sure your Housing Authority has the required number of UFAS accessible units OR if not, that your Housing Authority use the HUD Capital Funds to reach the minimum number.
