Title: Temporary Changes to TANF & Food Stamps Allocations

Purpose:

The purpose of this Communiqué is to inform you that the TANF and Food Stamps (FS) allocation amounts for **all** CCIS agencies will be **temporarily** modified beginning Thursday, December 6, 2007.

Discussion:

As a result of the TANF Family Support Services (FSS) payment calculation formula that was introduced into the CCIS Invoice payment process with Release 4, it is necessary for us to monitor and adjust the distribution of the TANF and FS allocations for FSS. Redistribution of the FSS allocations within PELICAN is necessary in order to ensure the fullest FSS payment possible to each CCIS.

We anticipate that all allocation amounts will be returned to their correct amounts within the next two weeks.

Allocation Change Process:

1. OCDEL enters funding transfers into PELICAN – which changes the TANF and FS service allocations.
2. OCDEL modifies FSS allocation amounts to redistribute among TANF and FS funding sources – which corrects the FSS allocations.
3. Comptroller's Office reviews and approves funding transfers in PELICAN – which returns the Service allocations to normal.
