

ESC Supplement Extract for Managed Care Encounters Layout

Scope: This output file is an extract of Behavioral, CCR EPOMS, Physical, and Community Health Managed Care 837 and NCPDP Encounters which processed in PROMISe™ for the previous day where the Paid or Denied Encounter set at least one PROMISe™ Error Status Code (ESC). Any Behavioral, CCR EPOMS, Physical, and Community Health 837 or NCPDP Encounters that did not set any ESCs will not be in this extract.

Format: Fixed width, not delimited, and with EOF (end-of-file). The total record length is 153 characters.

Frequency: Daily.

File Name: ESCLIST[4 digit sequence].CCYYMMDD.XX.txt

- 4-digit sequence used to uniquely identify the file.
- CCYYMMDD is date the file is created for the MCO Plan.
 - CCYY = Year, MM = Month, DD = Day, and XX = Plan Code.

The ASCII text file (.txt) will be zipped due the size of the file.
