

PACTT Affiliate Public Report

Agencies affiliated with the Pennsylvania Academic, Career and Technical Training (PACTT) Alliance have voluntarily agreed to meet standards in one or more of the following areas: Academics; work related services; and job skills training. Through their efforts, the affiliated agencies work to support goals outlined in the Advancing Competency Development: A White Paper for Pennsylvania and Pennsylvania’s Juvenile Act. These include, but are not limited to:

- Helping youth improve their chances of having a successful educational experience.
- Developing a set of study and learning skills and basic reading, writing, and math skills.
- Helping youth to catch up in school and advance in school to the highest possible level of academic achievement.
- Developing workforce skills for getting a job, keeping a job, and achieving promotion.
- Developing workforce programs that promote economic self-sufficiency, are grounded in principles of youth development, and connected to further education and long-term career opportunities.
- Helping older youth improve their chances of being economically self-sufficient after high school.
- Developing competencies that will enable youth to become responsible and productive members of the community.

Limitations of this report should be noted. Data included in the report includes only those youth that were determined by the affiliate to have successfully completed the program and were recommended for discharge. In addition, academic data does not include youth having received services for less than 90 days. As a result, the average length of stay for youth in the affiliation areas may differ. Data included in the report was based on self-reported information provided by the affiliated agency. Reports were generated, using the PACTT database, by the affiliate and reviewed by the affiliate for accuracy prior to being posted for public viewing.

Program Description:

Located in Morgantown, Pennsylvania just minutes from the Pennsylvania Turnpike exit 298, Abraxas Academy is one of the few Joint Commission accredited and Sanctuary Model certified secure programs in the state of Pennsylvania.

The Abraxas Academy uses The Sanctuary Model® for Trauma Informed Care as the framework for treatment. The Sanctuary Model is a blueprint for clinical and organizational change which, at its core, promotes safety and recovery from adversity through the active creation of a trauma-informed community. Sanctuary emphasizes: the importance of healing from psychological and socially traumatic experiences; community principles; restoring connections with others; and mutual accountability through the S.E.L.F. Model and the Seven Commitments. The Seven Commitments include Non-Violence, Emotional Intelligence, Social Learning, Democracy, Open Communication, Social Responsibility, & Growth and Change.

Abraxas Academy, located in Morgantown, Pennsylvania is a multi-service facility which offers Secure Residential Treatment and Secure Detention Services.

Our secure residential treatment program provides specialized care for delinquent male youth between the ages of 14 to 18 in 9th grade or above. Treatment at the Academy is for youth who demonstrate a consistent display of delinquent patterns through multiple placements, serious charges, and problematic behaviors. Youth are admitted to the Academy for either habitual offending behaviors or for a history of sexual offending behavior.

Abraxas Academy opened in October of 2006 and is located in Morgantown, Pennsylvania. Abraxas Academy is classified as a secure residential treatment facility. It provides care and treatment to delinquent male adolescents who demonstrate a variety of issues including behavioral health and sexual offending. All residents are court ordered for care and treatment. Facility services are provided seven (7) days a week, twenty-four (24) hours a day.

- Utilize PACTT’s *Employability and Soft Skills Manual (ESSM)* with all youth, age 14 and older.
- Document ESSM training progress and at the discharge, includes this information as part of the youth’s educational record and probation discharge packet.
- Develop a discharge portfolio for youth that indicates their progress toward completion of competencies.
- Offer opportunities for remediation in numeracy and literacy, credit recovery and/or acceleration.
- For youth having a disability, facilitate their involvement with the Office of Vocational Rehabilitation.
- Assist youth in accessing career/technical training, post-secondary education and job placement opportunities.
- Offer at least one (1) of the following basic certificates: OSHA-10, ServSafe, MOS; International Computer Driving License (ICDL).

The Abraxas Academy is an Approved Private Academic School and the Educational Administrative entity that governs the educational program. We offer an array of academic classes in English, mathematics, science, social studies, art, audio/visual production and media, health and Physical Education in a classroom setting with very low student to teacher ratios. We offer additional science electives in horticulture and botany. It is our goal to help students progress and meet the requirements to achieve an Abraxas Academy High School Diploma. We help students continue to gain academic credits for re-entry to their home school, or prepare them to graduate with a Commonwealth GED

If extra assistance is needed in an academic subject or more individualized intervention is needed, they are able to receive tutoring from our intervention specialist. This position is utilized in order to help students on a more one on one interaction. We also provide a life skills class to all of our students which teaches job skills training and follows the PACTT core comp entices throughout a 27 week curriculum.
General description of how the agency offers GED courses or makes them available through another entity.	Abraxas Academy is a certified testing center where students are not only able to be tutored for the GED but also able to take the GED tests at our facility.

Description of the agency’s Special Education services.	<p>Abraxas Academy's Special Education Department is comprised of the Special Education Teachers, Intervention Specialists, and a Special Education Supervisor. The facility offers Emotional and Learning Support. Any related service, such as Speech Therapy or Occupational Therapy is provided by an outside agency, which is arranged by the Special Education Supervisor. This service can be either provided in person or on the computer via a video chat. Intervention Specialists assist the teachers in both behavioral and educational support for the students with an IEP. The Intervention Specialist can also provide 1:1 assistance if the student is in need of it. This is not for full-time support, but for taking tests or completing assignments outside the class in which the student is struggling.</p> <p>If a student has an out of state IEP or the Evaluation or Reevaluation Report that is out of date, Abraxas contracts with the Berks County Intermediate Unit to ensure testing is completed. This is the same case for an Evaluation or Reevaluation reports that need to be updated to meet PDE compliance. Also, in accordance with PDE, IEP meetings are held within 30 days of receiving the Special Education records for a student. The meetings are conducted in person or via phone.</p>

Additional Program Information

The Abraxas Academy has two residential programs: the Habitual Offenders Program and the Sexual Offenders Program.

The Habitual Offenders Treatment Program for males uses a comprehensive approach in providing treatment services to the residents. This is achieved through trauma informed cognitive behavioral therapy with a strong emphasis on functional behavior assessment and behavioral treatment. The program milieu and curriculum utilize the principles of BARJ, Applied Behavioral Analysis and a cognitive distortions component. On-Track: Overcoming Life's Hurdles a habitual offender specific group curriculum provides a treatment emphasis is placed on identifying and correcting potentially harmful patterns of thought, improving social skills, teaching problem solving skills and developing an awareness of the community and victim, while altering target pro-social and maladaptive behaviors.

The Sexual Offenders Program is designed to provide specialized treatment services to sexual offenders. This specific program is an evidenced based approach to sex offender treatment utilizing the Risks-Needs-Responsivity (RNR) model of offender rehabilitation addressing the "big" three rehabilitation principles of risk, need, and responsivity. Residents are taught to be accountable for their actions and recognize the consequences of inappropriate behavior. The program places a strong emphasis on assisting residents to improve social skills and maintain awareness of their own sexual past
