



PACTT AFFILIATE PUBLIC REPORT

Agencies affiliated with the Pennsylvania Academic, Career and Technical Training (PACTT) Alliance have voluntarily agreed to meet standards in one or more of the following areas: Academics; work related services; and job skills training. Through their efforts, the affiliated agencies work to support goals outlined in the Advancing Competency Development: A White Paper for Pennsylvania and Pennsylvania’s Juvenile Act. These include, but are not limited to:

- Helping youth improve their chances of having a successful educational experience.
- Developing a set of study and learning skills and basic reading, writing, and math skills.
- Helping youth to catch up in school and advance in school to the highest possible level of academic achievement.
- Developing workforce skills for getting a job, keeping a job, and achieving promotion.
- Developing workforce programs that promote economic self-sufficiency, are grounded in principles of youth development, and connected to further education and long-term career opportunities.
- Helping older youth improve their chances of being economically self-sufficient after high school.
- Developing competencies that will enable youth to become responsible and productive members of the community.

Program Description:

Easton Manor is open residential program that provides therapeutic services to adolescent males who have demonstrated problematic sexual behavior and have been either adjudicated delinquent or dependent by their referring County of origin. Youth participate in a structured CBT-based curriculum that addressed various aspects of their history of problematic sexual behavior through an exploration of Wellness, cognitive distortions, offense dynamics, and relapse prevention. Educational services are provided on-site. As well, Life Skills and Independent Living Skills taught to ensure program youth's success in all aspects of their lives. As well, industry recognized certifications are provided for future job readiness.

Overview of General PACTT Requirements for all Affiliates:

- *Utilize PACTT's Employability and Soft Skills Manual (ESSM) with all youth, age 14 and older.*
- *Document ESSM training progress and at the discharge, includes this information as part of the youth's educational record and probation discharge packet.*
- *Develop a discharge portfolio for youth that indicates their progress toward completion of competencies.*
- *Offer opportunities for remediation in numeracy and literacy, credit recovery and/or acceleration.*
- *For youth having a disability, facilitate their involvement with the Office of Vocational Rehabilitation.*
- *Assist youth in accessing career/technical training, post-secondary education, and job placement opportunities.*
- *Offer at least one (1) of the following basic certificates: OSHA-10, ServSafe, MOS; International Computer*
- *Driving License (ICDL).*

Academic Information

- *Maintain a rigorous academic curriculum fully aligned with Pennsylvania's Academic Standards.*
- *Perform transcript audits for youth to prioritize education programming and to determine if any individual needs exist.*
- *Test youth upon admission to determine their academic abilities and to ensure appropriate placement in academic subjects.*
- *Test youth prior to discharge to identify educational gains made.*
- *Ensure the availability of certified Special Education teachers as required by the Pennsylvania Department of Education (PDE).*
- *Provide supports for youth who have special needs in their Individualized Education Program (IEP).*
- *Provide opportunities for youth to obtain a GED and connect them with post-secondary training and career opportunities.*
- *Request and transmits school records within the timeframe required by PDE.*
- *Provide individual case management to support youth's transition to school.*
- *Provide supports for English Language Learners (ELL).*
- *Align academic courses and course descriptions with PDE's Pennsylvania Information Management System (PIMS).*
- *Whenever possible, provide instruction through low youth-to-teacher ratios.*
- *Provide staff with regular professional development.*

Edison Prep supplies the educational services for Mathom House and Easton Manor. Each of our teachers is certified in one or more content areas of instruction. We supply a diversity of courses in small learning group sections. We design our classes utilizing the Pa Standards Aligned System (SAS) and in partnership with our sending districts.

We offer a broad range of elective courses including, but not limited to, The Chemistry of Ceramics, Mindful Gardening, Creative Expressions, Textiles, Sewing, Building a Tiny Wind and Solar Classroom Project, and Project History to name just a few. Additionally, we offer a full range of guidance counseling and college planning services.

We offer one to one and small group classes.

Work Related Services

Overview of PACTT Work Related Services Affiliation Requirements:

- *Conduct a work skills assessment with all youth between the age of 14-21.*
- *Conduct an interest assessment with all youth between the age of 14-21.*
- *Directly offer, or make available through another entity, opportunities for youth to participate in a paid work-based learning experience.*
- *Ensure that an evaluative process is in place, to include providing youth with regular feedback about their performance.*
- *Establish relationships with employers to provide paid work experience opportunities for youth.*
- *Establish connections for youth with employment resources.*
- *In youth's area(s) of interest, identify potential employers in the communities where youth currently live or will be returning to after placement.*
- *Review the Department of Labor and Industry's High Priority Occupations with youth, to include those from the region where they will be living.*

Additional Program Information

As of late December 2021, 5 out of the 7 residents have gained employment at local establishments (Giant, Dollar Tree, MOD Pizza, BJ's and Uno's).
