

PACTT Affiliate Public Report

Agencies affiliated with the Pennsylvania Academic, Career and Technical Training (PACTT) Alliance have voluntarily agreed to meet standards in one or more of the following areas: Academics; work related services; and job skills training. Through their efforts, the affiliated agencies work to support goals outlined in the Advancing Competency Development: A White Paper for Pennsylvania and Pennsylvania’s Juvenile Act. These include, but are not limited to:

- Helping youth improve their chances of having a successful educational experience.
- Developing a set of study and learning skills and basic reading, writing, and math skills.
- Helping youth to catch up in school and advance in school to the highest possible level of academic achievement.
- Developing workforce skills for getting a job, keeping a job, and achieving promotion.
- Developing workforce programs that promote economic self-sufficiency, are grounded in principles of youth development, and connected to further education and long-term career opportunities.
- Helping older youth improve their chances of being economically self-sufficient after high school.
- Developing competencies that will enable youth to become responsible and productive members of the community.

Limitations of this report should be noted. Data included in the report includes only those youth that were determined by the affiliate to have successfully completed the program and were recommended for discharge. In addition, academic data does not include youth having received services for less than 90 days. As a result, the average length of stay for youth in the affiliation areas may differ. Data included in the report was based on self-reported information provided by the affiliated agency. Reports were generated, using the PACTT database, by the affiliate and reviewed by the affiliate for accuracy prior to being posted for public viewing.

Program Description:

The Summit Academy is a private, residential school for at-risk young men, ages 12-18 in grades 7-12. The school provides a multi-faceted approach to rehabilitation and recovery for students who have experienced substantial trauma and challenges in their pasts. Interweaving academics, substance abuse treatment, mental health therapy, counseling, trades training, community services, arts and athletics, we provide a transforming environment and unwavering support system that allows these young men to redirect their lives and their futures.

Overview of General PACTT Requirements for all Affiliates:

- Utilize PACTT’s Employability and Soft Skills Manual (ESSM) with all youth, age 14 and older.
- Document ESSM training progress and at the discharge, includes this information as part of the youth’s educational record and probation discharge packet.
- Develop a discharge portfolio for youth that indicates their progress toward completion of competencies.
- Offer opportunities for remediation in numeracy and literacy, credit recovery and/or acceleration.
- For youth having a disability, facilitate their involvement with the Office of Vocational Rehabilitation.
- Assist youth in accessing career/technical training, post-secondary education and job placement opportunities.
- Offer at least one (1) of the following basic certificates: OSHA-10, ServSafe, MOS; International Computer Driving License (ICDL).

- *Ensure the availability of certified Special Education teachers as required by the Pennsylvania Department of Education (PDE).*
- *Provide supports for youth who have special needs in their Individualized Education Program (IEP).*
- *Provide opportunities for youth to obtain a GED and connect them with post-secondary training and career opportunities.*
- *Request and transmits school records within the timeframe required by PDE.*
- *Provide individual case management to support youth’s transition to school.*
- *Provide supports for English Language Learners (ELL).*
- *Align academic courses and course descriptions with PDE’s Pennsylvania Information Management System (PIMS).*
- *Whenever possible, provide instruction through low youth-to-teacher ratios.*
- *Provide staff with regular professional development.*

General description of how the agency provides instruction in the areas of English; mathematics, science, social studies; physical education and health; and fine arts.

The Summit Academy operates a six period school day that incorporates the core curriculum as well as time for trades, work, extracurricular activities and community service experiences. The core curriculum is aligned with the Pennsylvania Department of Education academic standards. Remediation, IEP services, enrichment and credit recovery are offered.

General description of academic services the agency provides beyond those required by the Department of Education.

The academic department works on a case-by-case basis with each student to develop the best plan for the student's success, whether it be utilizing credit recovery, pursuing a GED, continuing with general education in anticipation of returning to his home school district or graduating the student from our school. The Summit Academy takes pride in postsecondary education and offers two College Within The High School classes each semester. The Summit Academy also offers a generous scholarship program to Summit Academy High School graduates so that they may pursue their postsecondary education.

General description of how the agency offers GED courses or makes them available through another entity.

The Summit Academy offers a supplemental GED program where students are able to simultaneously earn high school credits in the event that they do not successfully pass the exam. The supplemental program focuses on pretesting and working on areas of weakness so that the student has the best chance of earning a GED. Students receive group and individualized instruction. Currently over 20 students are participating in this program.

General description of how the agency offers credit recovery courses or makes them available through another entity.

The Summit Academy uses the Edmentum software to assist in credit recovery for students. Each student receives a credit review upon entry to determine if credit recovery is needed and can be accomplished with the student's current credit needs. Sometimes students' schedules will be altered to utilize the computer platform; sometimes the student may attend two physical classes.

Description of the agency's credit bearing/non-credit bearing summer school programming.

The Summit Academy operates year-round with five marking periods offering the six core courses.

Description of the agency's Special Education services.

The Summit Academy has a special education office staffed by a coordinator and several certified teachers. The students are baseline tested upon entry, and a new IEP is developed within 60 days of arrival to make sure all needs are met. The school contracts with a school psychologist to conduct re-evaluations and new evaluations as requested. Special education teachers progress monitor the students and send regular reports home to parents and guardians. The school has implemented a new emotional support program.

Description the agency's English as Language Learner (ELL) academic services.

The special education coordinator reviews all home language surveys to ensure we are meeting ELL needs. She coordinates services through the Intermediate Unit to service those students. The current special education coordinator obtained her English as a Second Language certificate to better serve the needs of this growing population.
