

## PACTT Affiliate Public Report

Agencies affiliated with the Pennsylvania Academic, Career and Technical Training (PACTT) Alliance have voluntarily agreed to meet standards in one or more of the following areas: Academics; work related services; and job skills training. Through their efforts, the affiliated agencies work to support goals outlined in the Advancing Competency Development: A White Paper for Pennsylvania and Pennsylvania’s Juvenile Act. These include, but are not limited to:

- Helping youth improve their chances of having a successful educational experience.
- Developing a set of study and learning skills and basic reading, writing, and math skills.
- Helping youth to catch up in school and advance in school to the highest possible level of academic achievement.
- Developing workforce skills for getting a job, keeping a job, and achieving promotion.
- Developing workforce programs that promote economic self-sufficiency, are grounded in principles of youth development, and connected to further education and long-term career opportunities.
- Helping older youth improve their chances of being economically self-sufficient after high school.
- Developing competencies that will enable youth to become responsible and productive members of the community.

Limitations of this report should be noted. Data included in the report includes only those youth that were determined by the affiliate to have successfully completed the program and were recommended for discharge. In addition, academic data does not include youth having received services for less than 90 days. As a result, the average length of stay for youth in the affiliation areas may differ. Data included in the report was based on self-reported information provided by the affiliated agency. Reports were generated, using the PACTT database, by the affiliate and reviewed by the affiliate for accuracy prior to being posted for public viewing.

**Program Description:**

Youth Forestry Camp #2 is located within Hickory Run State Park in Carbon County. It is an open residential facility for adjudicated delinquent male youth. Youth Forestry Camp #2 provides treatment, educational, and vocational services to youth, ages 13 to 20, based on their individual criminogenic needs. Opportunities for on-site and off-site internships, employment, and vocational training are also available. Youth are encouraged to participate in job programs which allow them to earn money to pay restitution costs.

Educational services are provided through agreements between the Pennsylvania Department of Education and the Carbon Lehigh Intermediate Unit. Instructional education is provided year round and offers a highly structured, small classroom environment designed to provide individual attention. Educational programs are designed to meet the needs of each resident. In order to best meet the educational needs of each resident, facility and educational staff work together to develop a comprehensive education plan and separate Individual Education Plan (IEP) as required for each student. Our faculty teaches core subjects as well as more specialized needs, such as life skills and vocational training including, but not limited to:

- Casey Life Skills
- GED - preparation/testing and credit recovery
- Vocational Certifications: OSHA-10 Certification; CPR/First Aid Certification; Forklift Operator; Flagger; etc.

**Overview of General PACTT Requirements for all Affiliates:**

- Utilize PACTT’s *Employability and Soft Skills Manual (ESSM)* with all youth, age 14 and older.
- Document ESSM training progress and at the discharge, includes this information as part of the youth’s educational record and probation discharge packet.
- Develop a discharge portfolio for youth that indicates their progress toward completion of competencies.
- Offer opportunities for remediation in numeracy and literacy, credit recovery and/or acceleration.
- For youth having a disability, facilitate their involvement with the Office of Vocational Rehabilitation.
- Assist youth in accessing career/technical training, post-secondary education and job placement opportunities.
- Offer at least one (1) of the following basic certificates: OSHA-10, ServSafe, MOS; International Computer Driving License (ICDL).

General description of how the agency provides instruction in the areas of English; mathematics, science, social studies; physical education and health; and fine arts.

Guidance counselors work to piece together all of the credits earned so that they can determine what is needed to graduate. The school then tailors instruction to the individual student and takes into consideration their academic level. Youth can receive academic course work up to 21 credits in the basic content areas which meets Pennsylvania's minimum standards.

General description of academic services the agency provides beyond those required by the Department of Education.

Resources provided by CLIU#21 include credit recovery, remediation, and acceleration and are available on a year round basis.

General description of how the agency offers GED courses or makes them available through another entity.

The school believes in the value of an earned high school diploma and makes every effort to allow students to obtain one if possible. If it is not possible, they provide GED services to students which include pre-testing, practice tests and taking the actual GED on site since the school is a Pearson Vue testing center.

General description of how the agency offers credit recovery courses or makes them available through another entity.

The school utilizes Lexia Learning for literacy remediation and Exactpath is the remedial program for math. They have the flexibility to design academic programs suited to the specific student's individual needs. CLIU#21 can offer any classes that are required as the student's work toward graduation, and these classes can be incorporated into the daily lessons.

Description of the agency's credit bearing/non-credit bearing summer school programming.

Instructional education is provided year round and offers a highly structured, small classroom environment designed to provide individual attention. Also during this time, the residential programs take advantage of the time by offering certificate and certification courses as well as workshops introducing students to different careers and opportunities.

Description of the agency’s Special Education services.	The schools observe all requirements of the Individuals with Disabilities Education Act (IDEA) and Chapter 14 of the PA Code, including child find obligations, the delivery of specially designed instruction to ensure a free and appropriate public education (FAPE) and meaningful progress. There are programs in place to address a full range of academic and functional needs, including interventions for reading, math, writing, behavior, and social skills. The schools obtain special education related services like speech and language support as students’ needs require.
