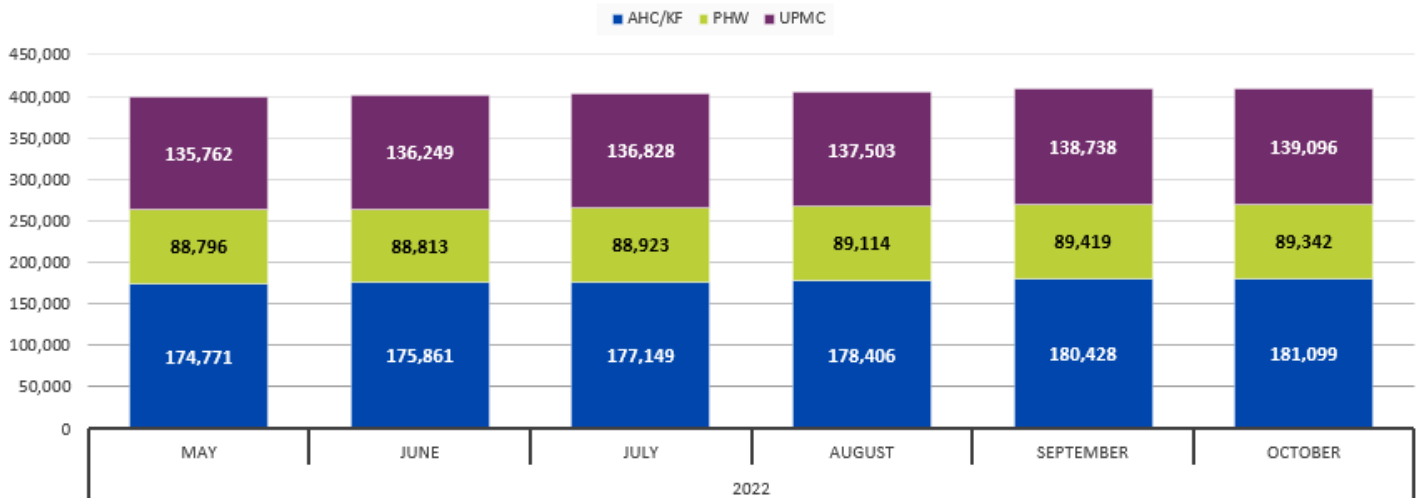

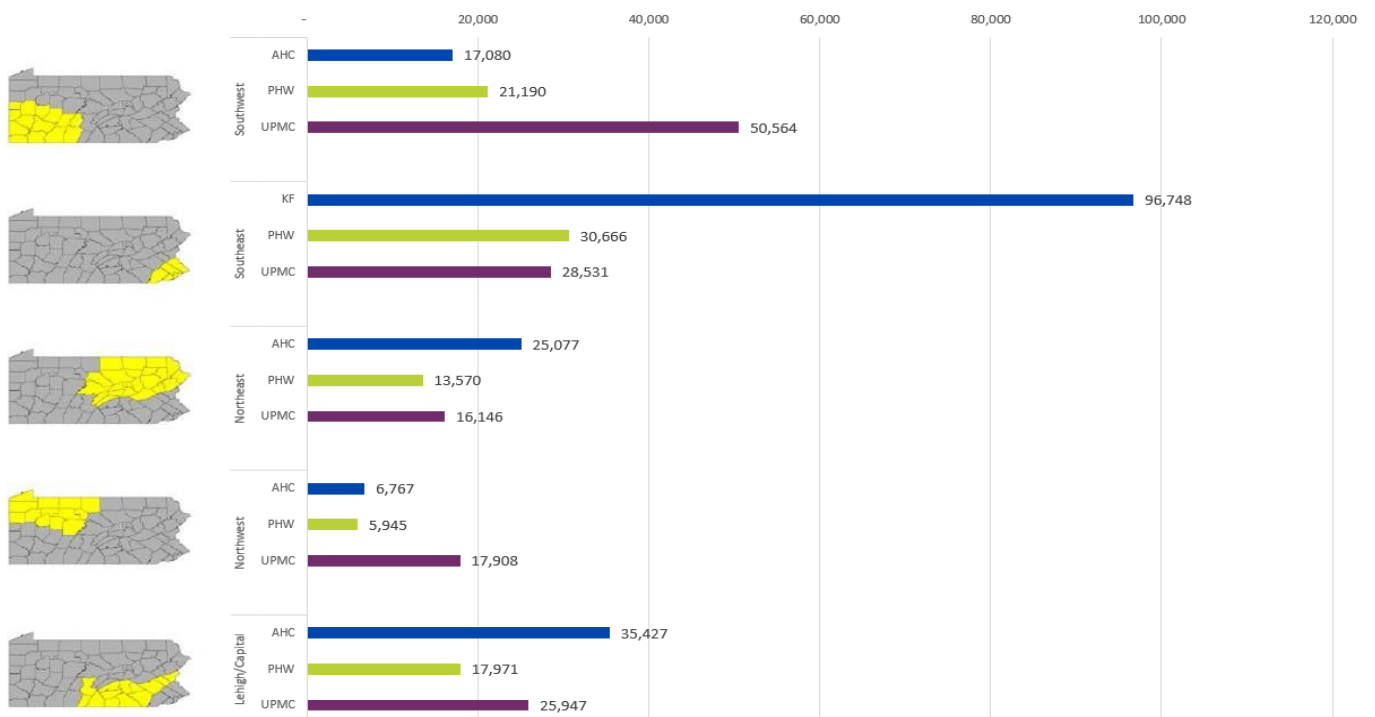
CHC Statewide Enrollments Trends by MCO

CHC Monthly Enrollment by Zone and MCO

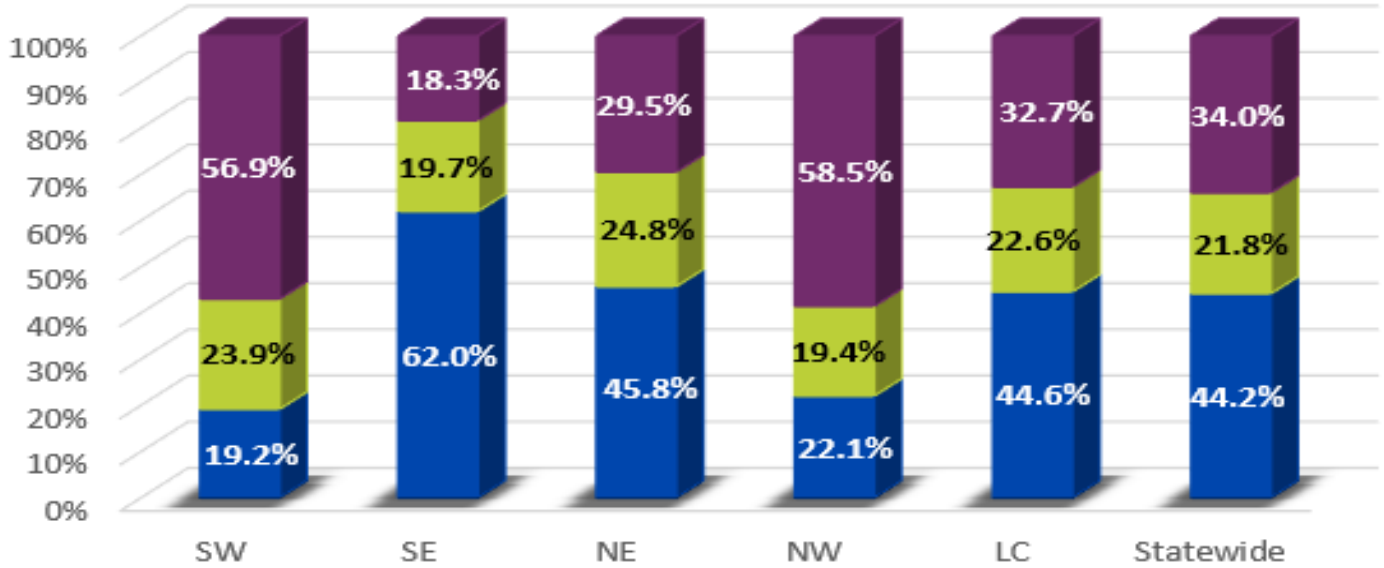

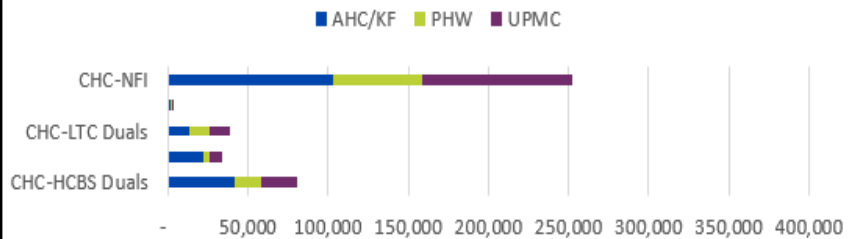

CHC Market Share by Population Group



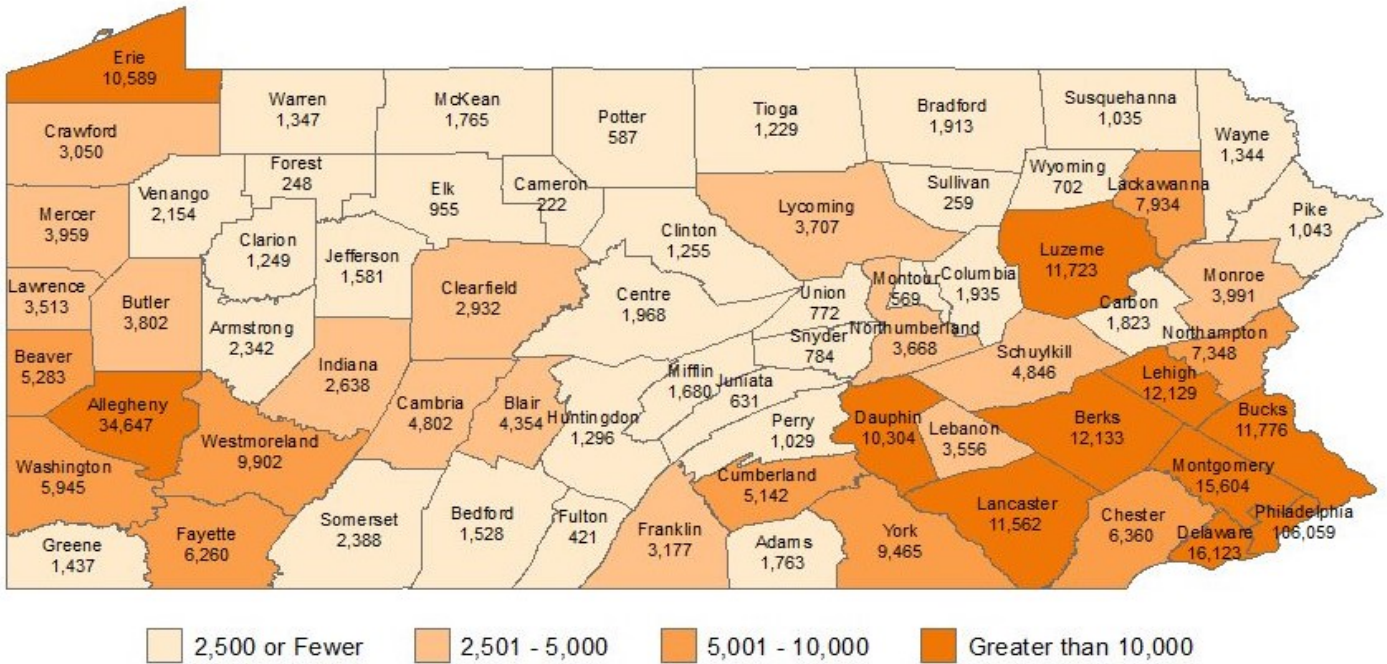

The NFI population continues to account for the majority of the population at 61.6%, this was a decrease from September. The percentage of HCBS participants increased to 28.1%, which is a 0.2% increase from last month. The LTC population decreased to 10.3%, this remained the same from the previous month.

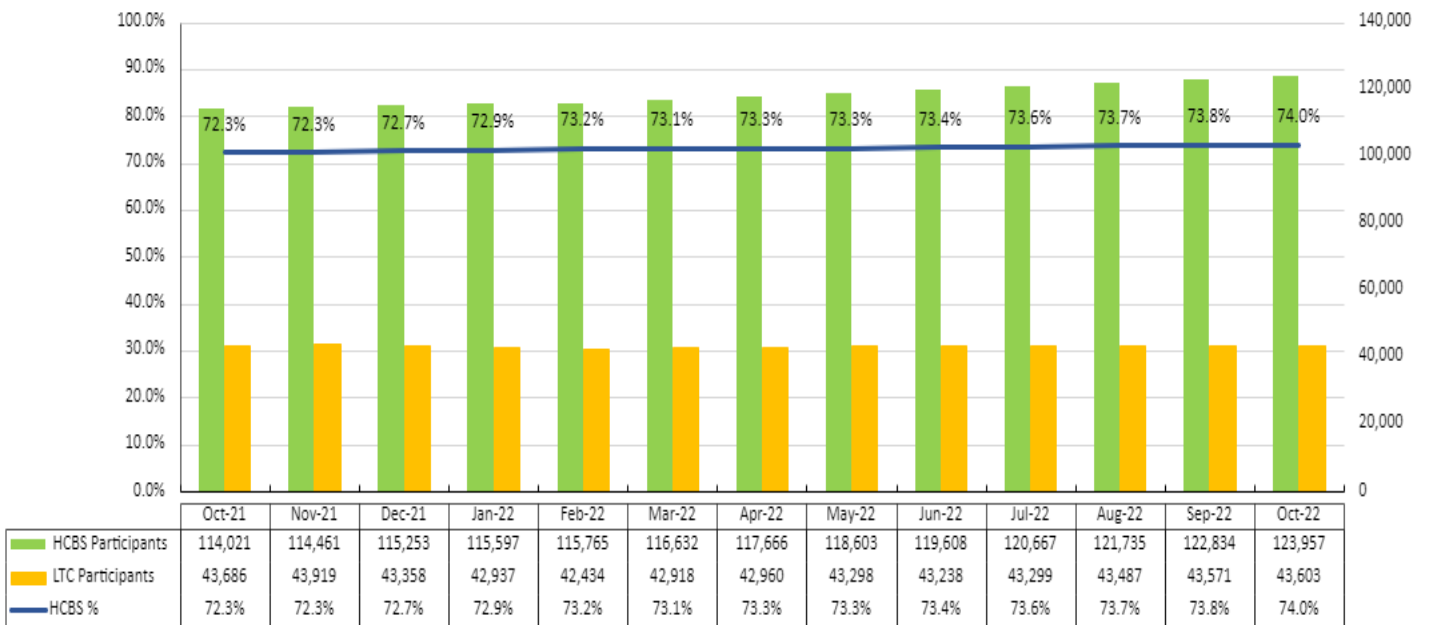
CHC Enrollments by County*

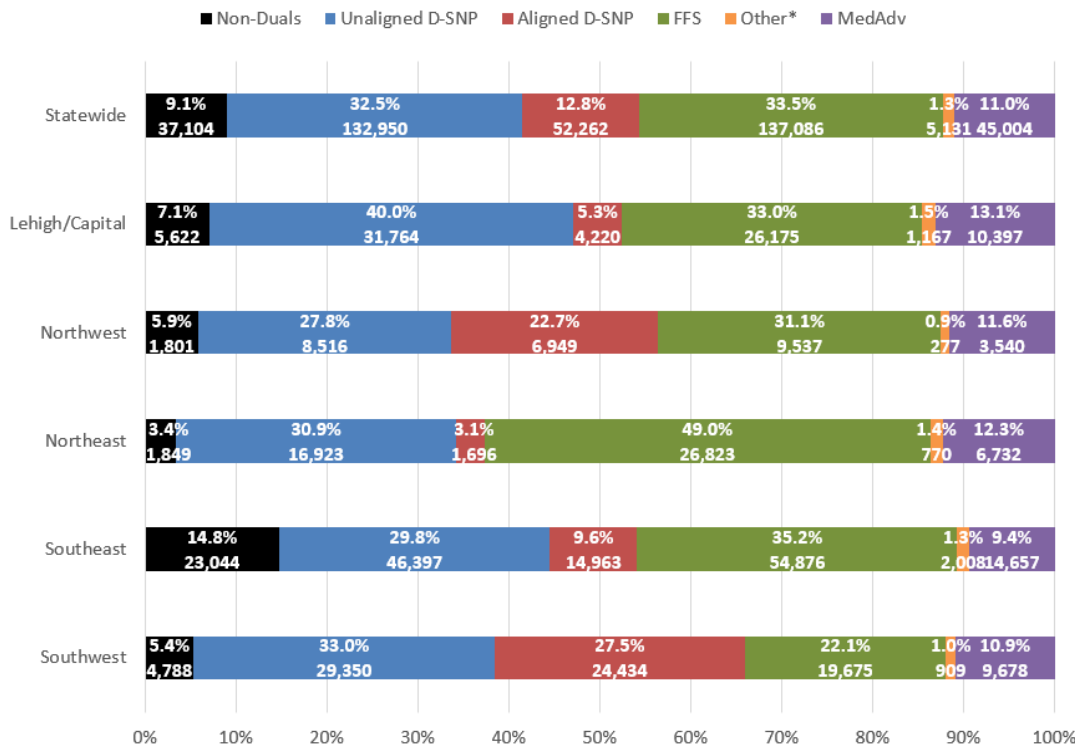
Statewide LTSS Population and HCBS Percentage

Medicare Type for All CHC Participants by Region**

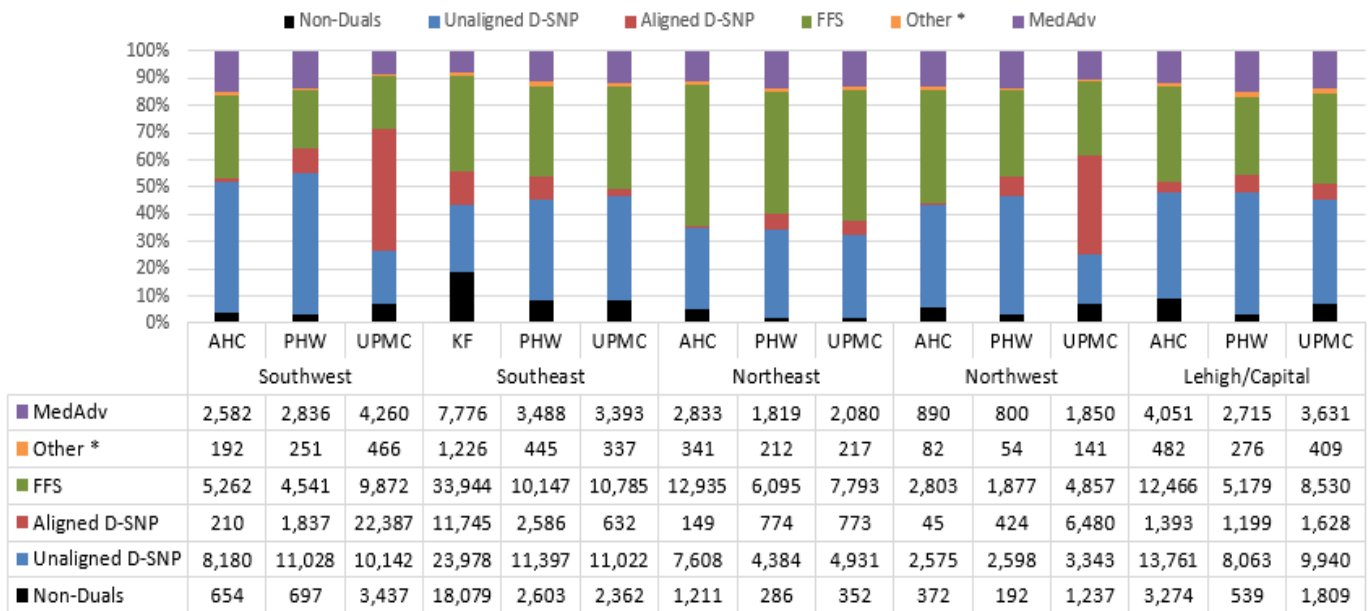


In October, the statewide percentage of non-duals increased from 9.0% to 9.1%. The percentage of participants in aligned D-SNPs increased from 12.7% to 12.8%, and the percentage of participants in unaligned D-SNPs increased from 32.3% to 32.5%. The percentage of participants in FFS Medicare decreased by 0.1% to 33.5%. Other Medicare Advantage increased by 0.1% to 11.0%.

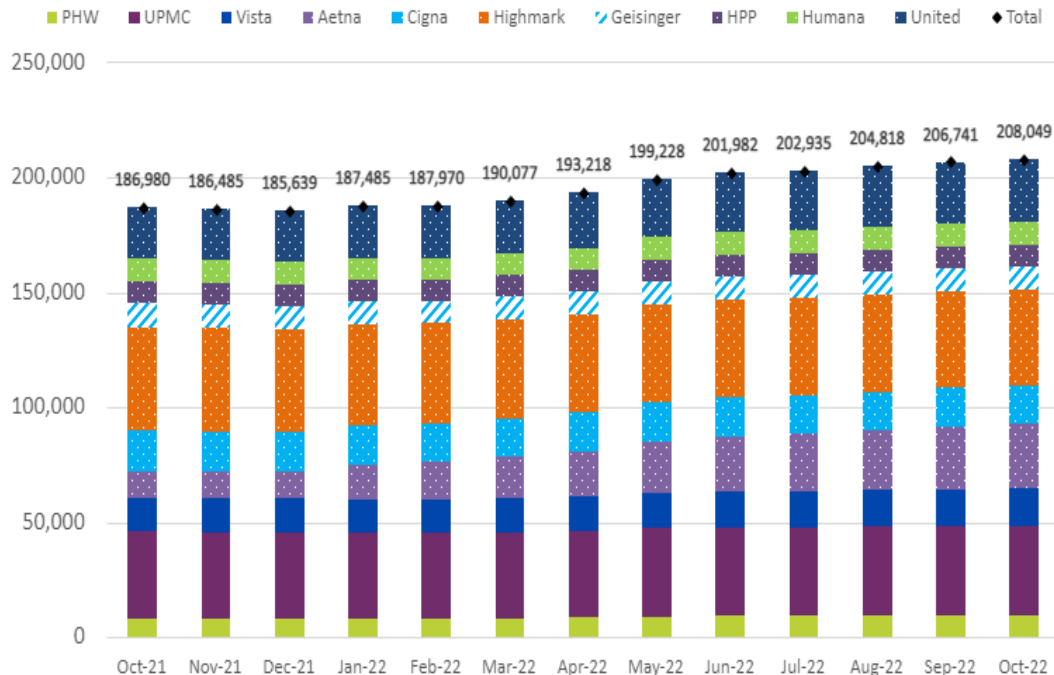

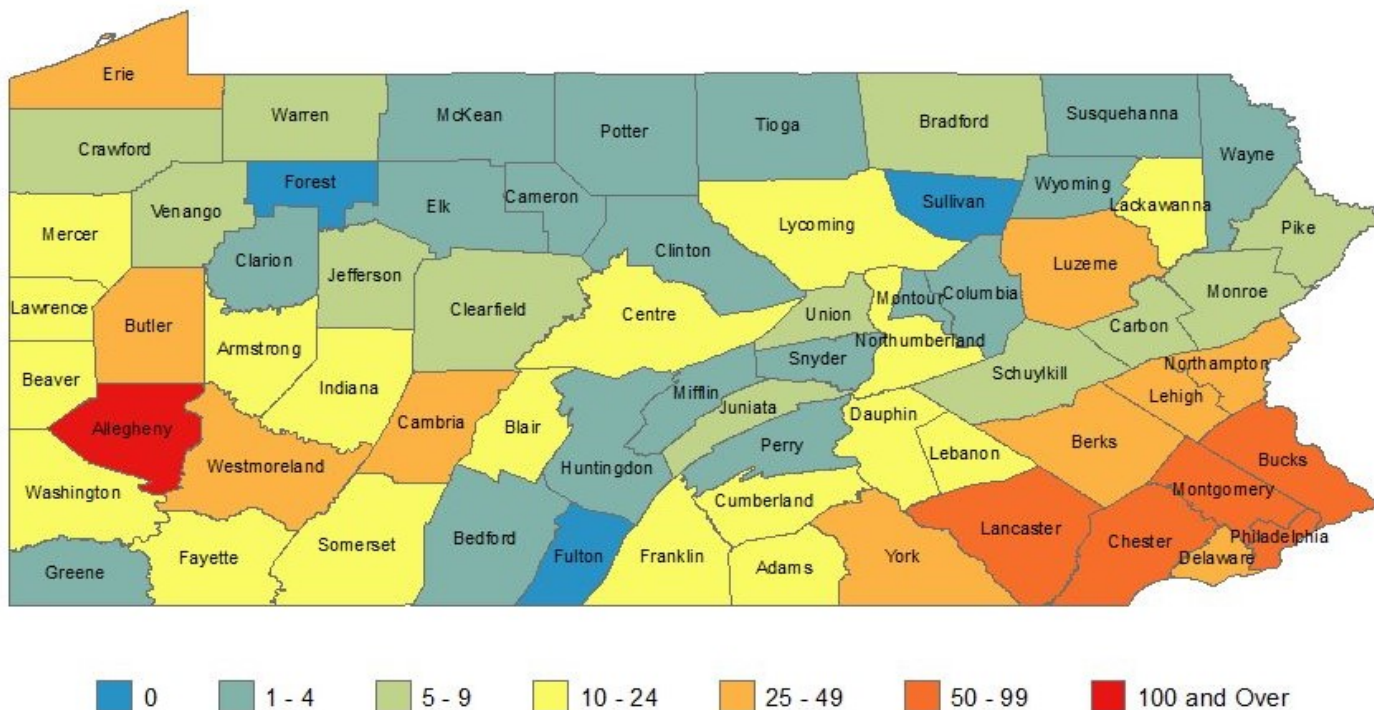
D-SNP Enrollments by Plan

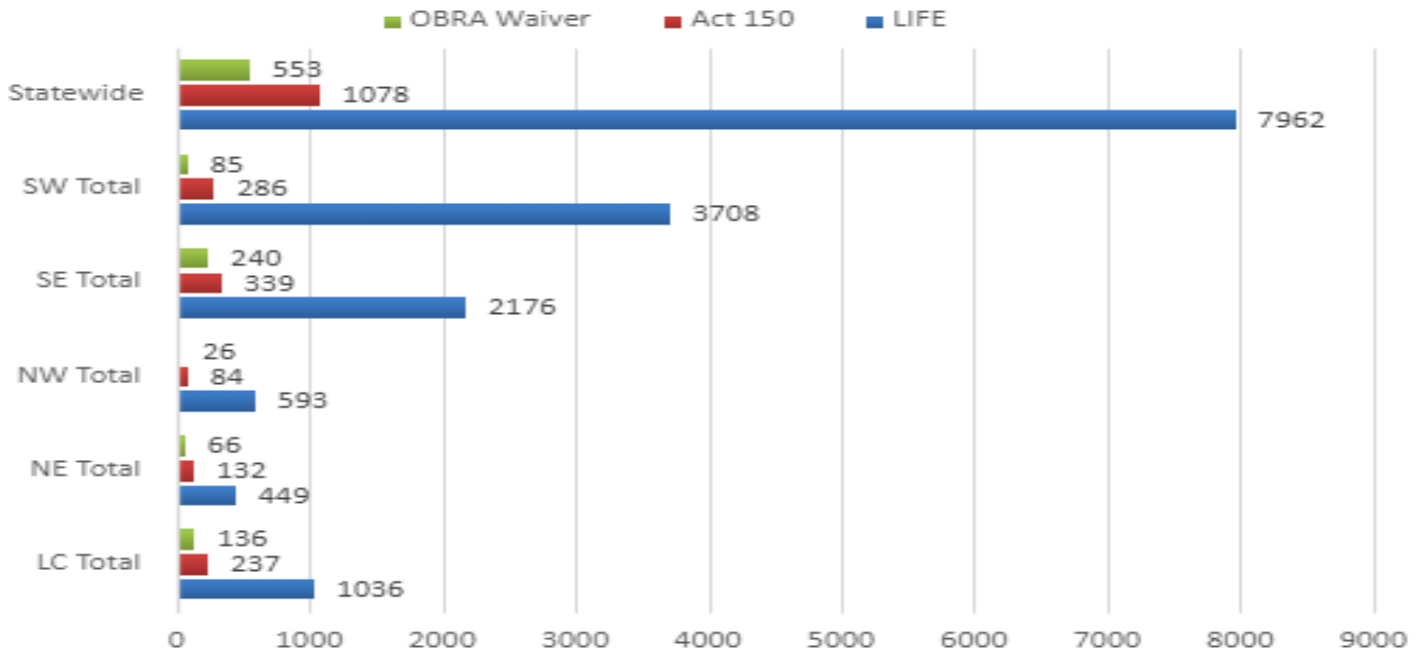

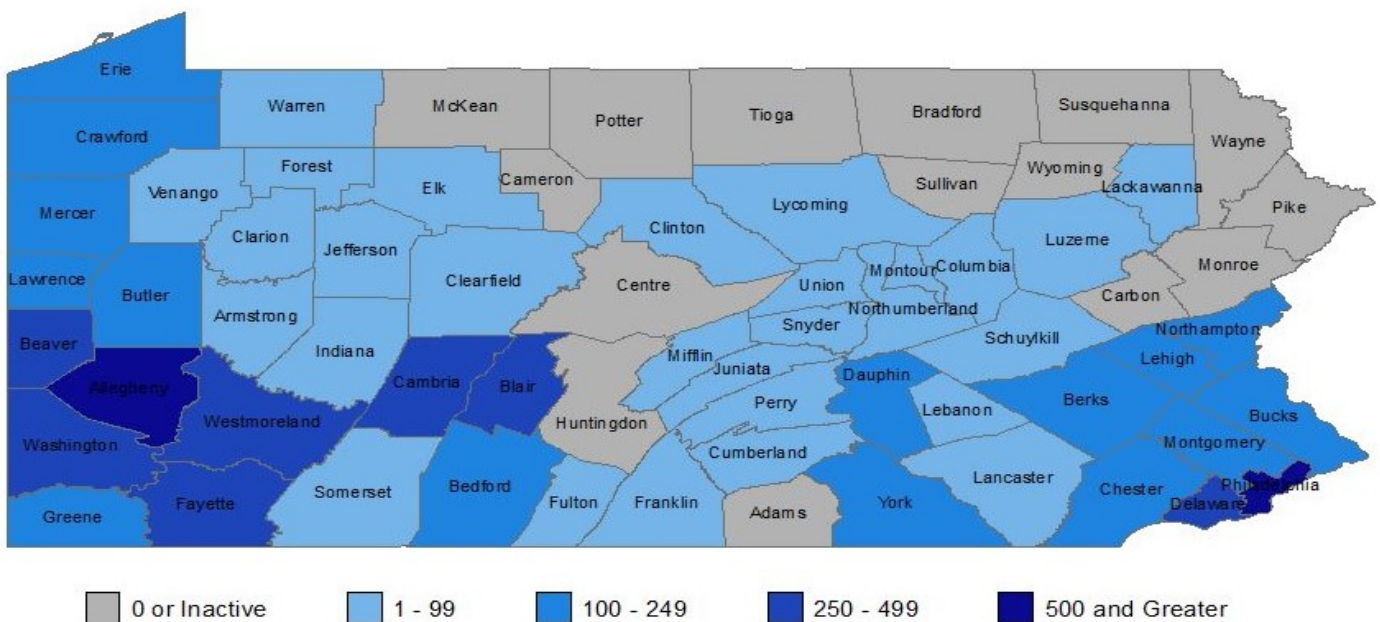
