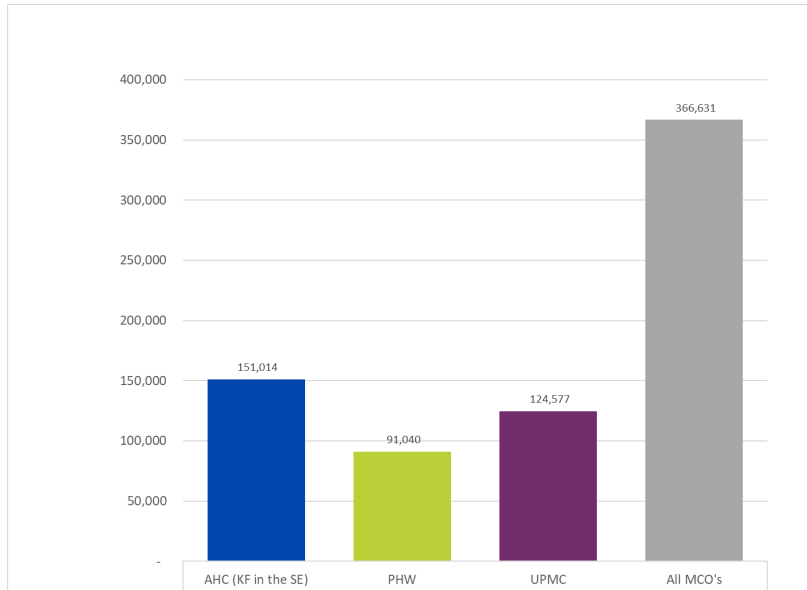

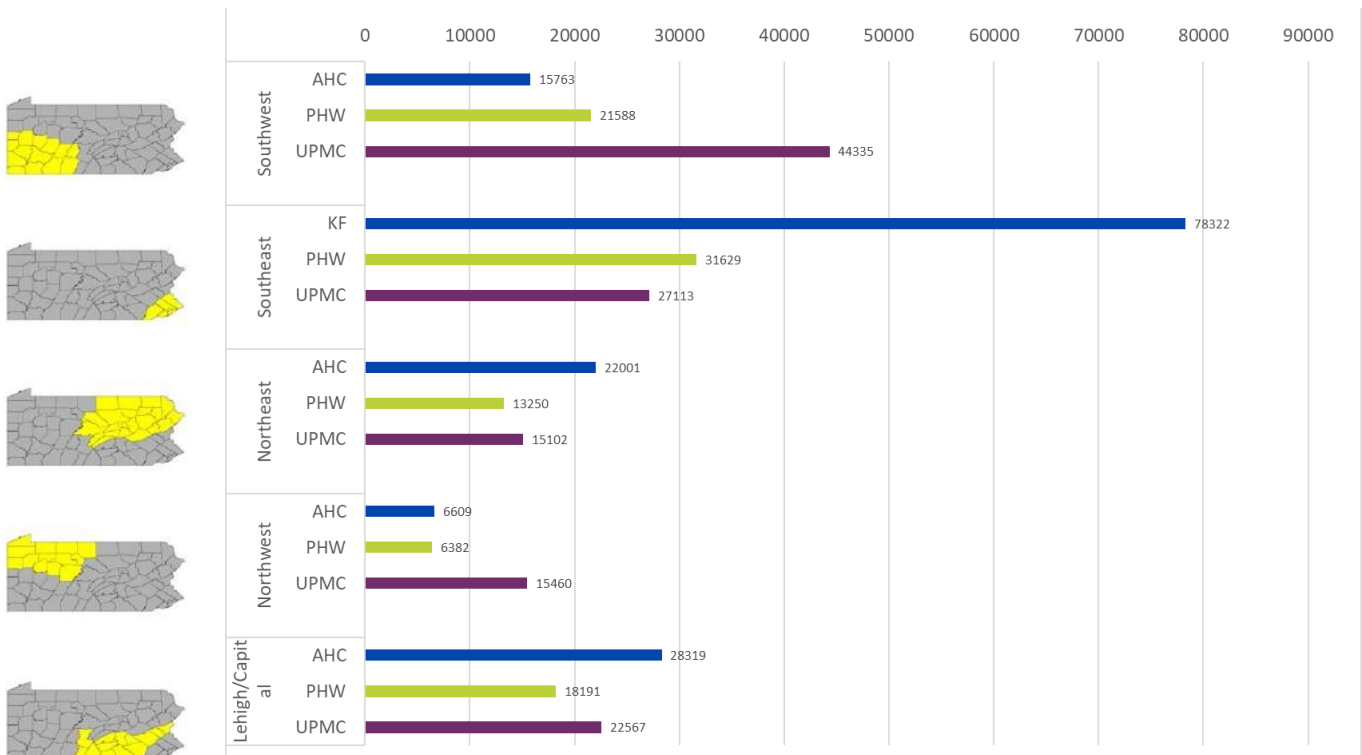
## Statewide Monthly Enrollments by MCO



Total CHC enrollment is 366,631, up from 364,630 in April.

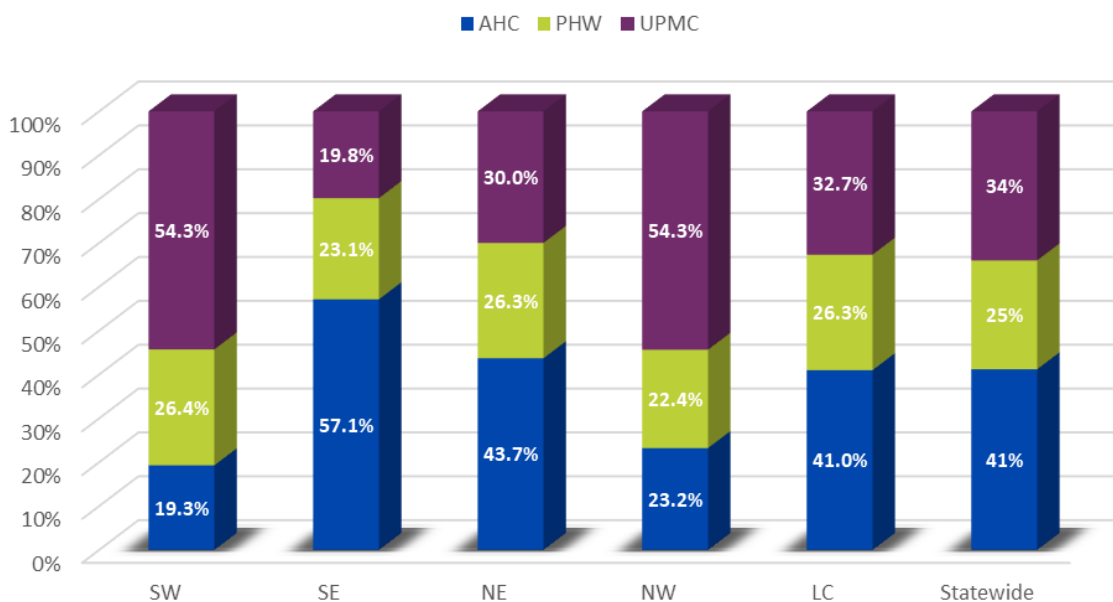

## CHC Monthly Enrollment by Zone and MCO



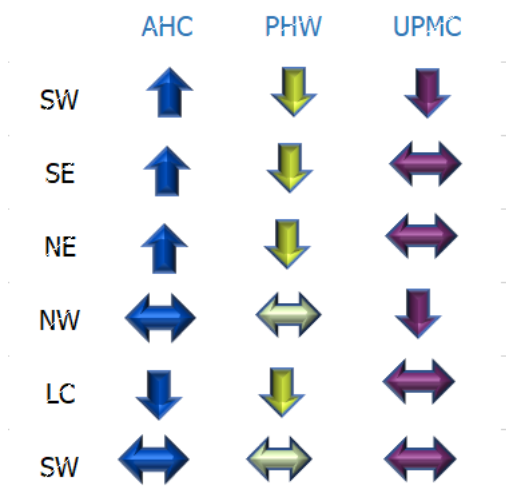

## CHC Market Share Chart



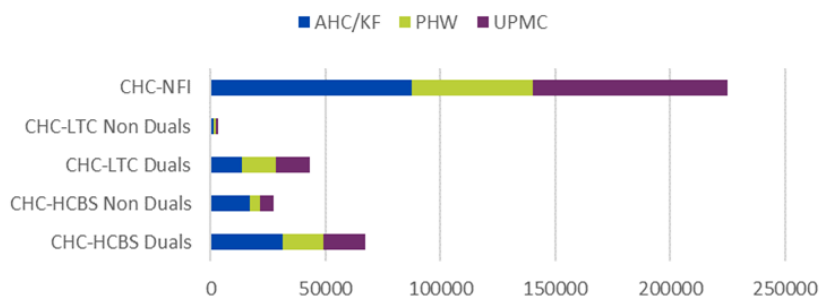

## April to May Changes



The graphic to the left reflects the changes from April's market share by MCO to May's market share by MCO. **It is important to note that all fluctuations are 1% or less and the minimal change between regions resulted in a net effect of no change at the statewide level.**

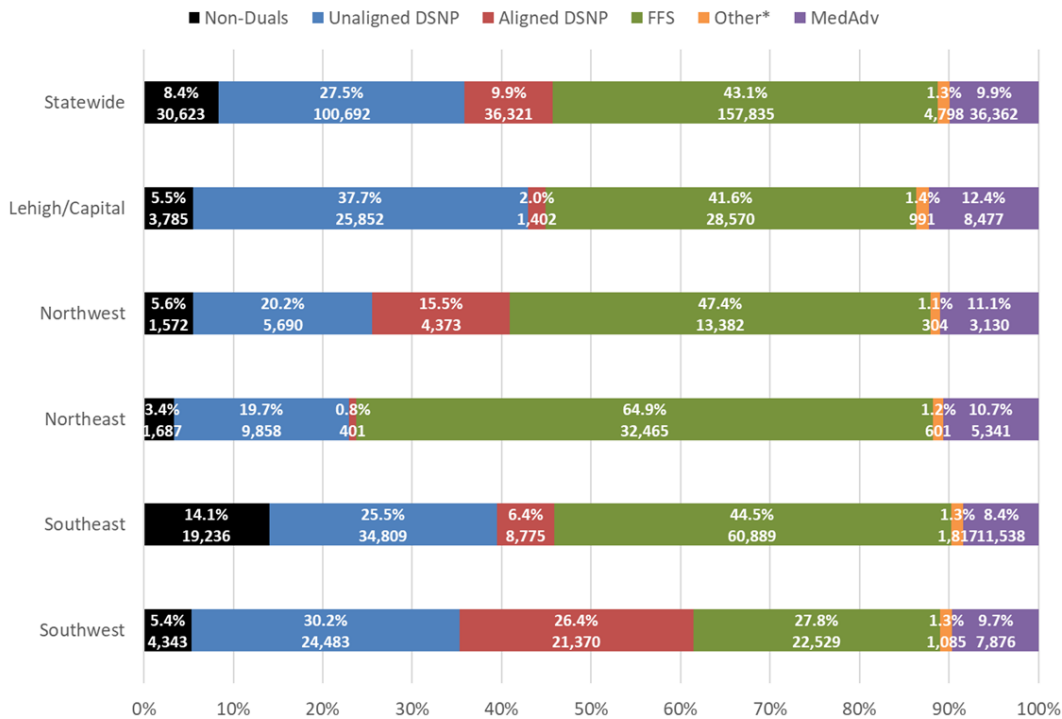
## CHC Market Share by Population Group

## Medicare Type for All CHC Recipients by Region

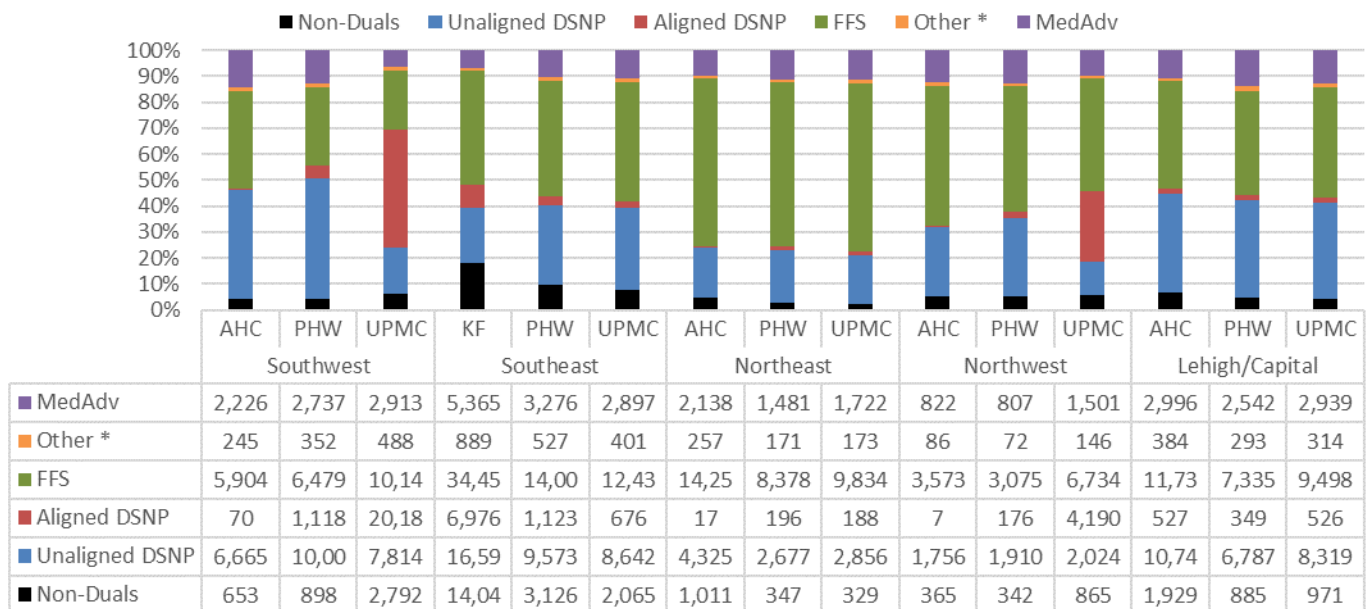

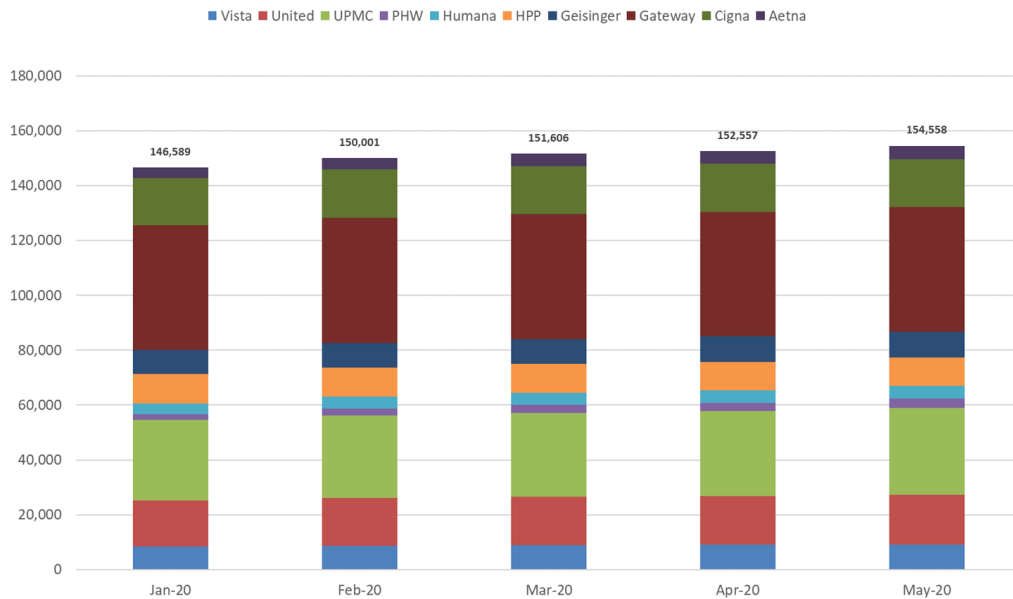
## Medicare Type by CHC Zone and Plan

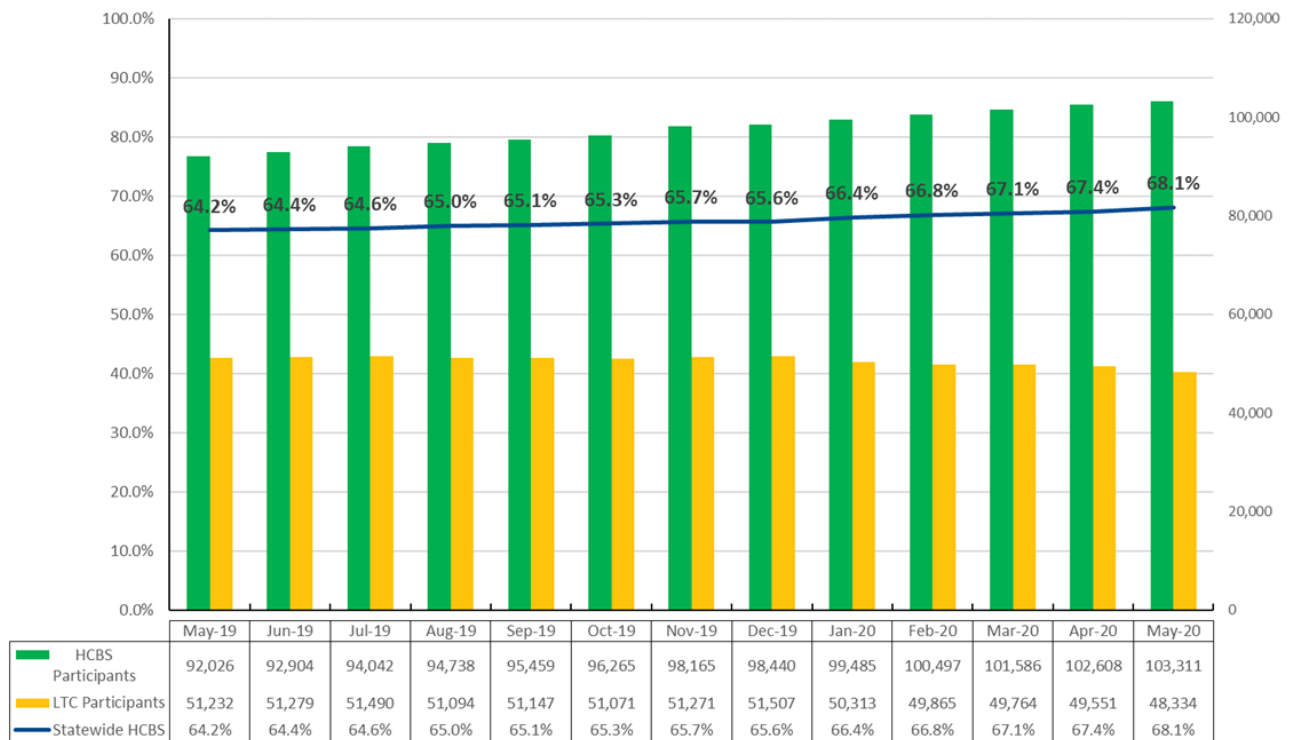

## D-SNP Enrollee Trending Data by Plan



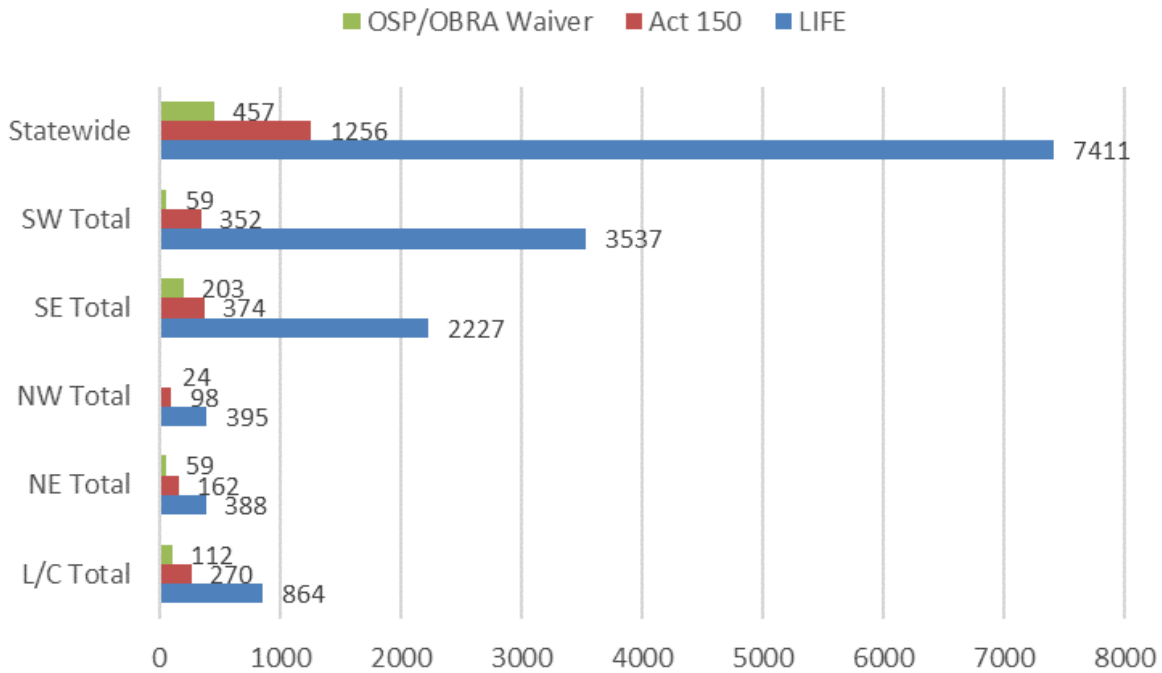
The rate of growth for D-SNP had declined from January through April by 3.8% from 4.4% to 0.6%, but increased from April to May by 1.3%.

## Statewide LTSS Population & HCBS Percentage



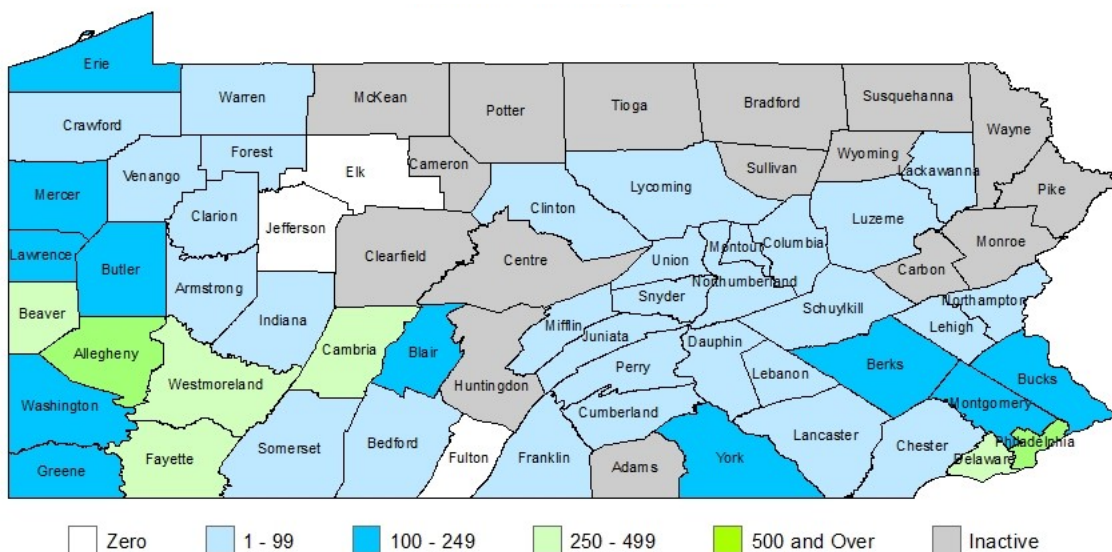
