



# CHC Monthly Enrollment by Zone and MCO







# CHC December to January Market Share Changes





The NFI population continues to account for the majority of the population at 61.5%, this was a small decrease from December. The percentage of HCBS participants increased to 28.4% from 28.3% for the previous month. The LTC population remained the same at 10.2%.






#### CHC Enrollments by County\*

\*Note: If a participant is in a nursing facility and has a home outside of the nursing facility, the participant is counted in the county of the nursing facility




# Statewide LTSS Population and HCBS Percentage






# Medicare Type for All CHC Participants by Region\*\*

In January, the statewide percentage of non-duals increased by 0.1% to 9.2%. The percentage of participants in aligned D-SNPs increased from 12.5% to 12.9%, and the percentage of participants in unaligned D-SNPs increased from 31.5% to 34.0%. The percentage of participants in FFS Medicare decreased from 33.7% to 31.5%. Other Medicare Advantage decreased by 0.5% to 11.0% .








**D-SNP Enrollments by Plan** 

D-SNP participants have increased 6.9% from December numbers. The overall enrollment numbers for 2022 has small increases month to month besides the previous two month, as depicted in the graph. We finished with a 9.3% increase for 2022.




# Number of Personal Care Homes and Assisted Living Facilities by County
