Required Documents for an Individual Provider Type 31:

The following documents and supporting information are required by the Bureau of Fee-For-Service Programs to enroll as a Provider Type 31 (please make sure all documents are legible):

- Completed application for an Individual Provider – application must include:
 - Signed Provider Agreement with an original Provider signature; and
 - Completed Ownership or Control Interest Disclosure form
- Copy of license issued by Department of State
- Copy of DEA certificate
- Copy of Board Certification, if applicable
- Copy of Mammography Certificate, if applicable
- Diabetes Training Certificate, if applicable
- Certificate of Completion for Application of Topical Fluoride Varnish, if applicable
- Copy of your PA Clinical Laboratory Permit and Clinical Laboratory Improvement Amendments (CLIA) Certificate, if applicant performs laboratory services
 - **Note:** BOTH In-State and Out-of-State Providers must submit a PA Department of Health-issued clinical lab permit if Provider seeks to bill for laboratory services
- If an Out-of-State Provider, proof of current home state Medicaid Participation
- For Specialty 426, Autism Certified Psychologist, if applying to provide services under the Adult Autism Waiver, a copy of the SPeCTRUM training certificate is needed

Required Documents for a Provider Type 31 Group:

- Completed application for a Group Provider – the application must include:
 - A signed copy of Provider Agreement with original signature of authorized representative;
 - and
 - Copy of Ownership or Control Interest Disclosure form
- Documentation generated by the IRS, showing both the Provider’s legal name and FEIN—documentation must come from the IRS; this Department **does not** accept W-9s
- If the application is for an Out-of-State Provider, submit proof of current home state Medicaid participation
- If the Group operates under a fictitious name, submit a copy of the D/B/A filing with Department of State Corporation Bureau
- Copy of Corporation paperwork issued by Department of State Corporation Bureau or business partnership agreement
- If Group is tax-exempt, submit IRS 501 (c)(3) letter confirming that status
