

PA PROMIS^e™ Claim Region Codes

Claims processed via Pennsylvania PROMIS^e™ are assigned a 13-digit Internal Control Number (ICN) upon receipt. The first two digits of the ICN are the region code. This code is used by PROMIS^e™ to denote the type of claim being processed
