**IMPORTANT REMINDER:** All providers must revalidate the Medical Assistance (MA) enrollment of each service location every 5 years. Providers should log into PROMISE to check the revalidation dates of each service location and submit revalidation applications at least 60 days prior to the revalidation dates. **PURPOSE:**

The purpose of this bulletin is to:

1. Inform providers of the addition of the Antivirals, Influenza class of drugs to the Preferred Drug List (PDL).
2. Issue new handbook pages that include the requirements for prior authorization and the type of information needed to evaluate the medical necessity of prescriptions for Antivirals, Influenza submitted for prior authorization.

**SCOPE:**

This bulletin applies to all licensed pharmacies and prescribers enrolled in the Medical Assistance (MA) Program and providing services in the fee-for-service delivery system. Providers rendering services in the MA managed care delivery system should address any questions related to Antivirals, Influenza to the appropriate managed care organization.

The Department of Human Services' (Department) Pharmacy and Therapeutics (P&T) Committee reviews published peer-reviewed clinical literature and recommends the following:

- Preferred or non-preferred status for new drugs in therapeutic classes already included in the PDL;
- Changes in the status of drugs on the PDL from preferred to non-preferred and non-preferred to preferred;
- New quantity limits;
- Classes of drugs to be added to or deleted from the PDL; and
- New guidelines or revisions to existing guidelines to evaluate the medical necessity of prescriptions submitted for prior authorization.

**DISCUSSION:**

During the May 15, 2019, meeting, the P&T Committee recommended that the Department add the Antivirals, Influenza class of drugs to the PDL and proposed guidelines to determine medical necessity of Antivirals, Influenza. The requirement for prior authorization and guidelines to determine medical necessity of Antivirals, Influenza, as recommended by the P&T Committee, were subject to public review and comment and subsequently approved for implementation by the Department.

**PROCEDURE:**

The procedures for prescribers to request prior authorization of Antivirals, Influenza are located in SECTION I of the Prior Authorization of Pharmaceutical Services Handbook. The Department will take into account the elements specified in the clinical review guidelines (which are included in the provider handbook pages in the SECTION II chapter related to Antivirals, Influenza) when reviewing the prior authorization request to determine medical necessity.

As set forth in 55 Pa. Code § 1101.67(a), the procedures described in the handbook pages must be followed to ensure appropriate and timely processing of prior authorization requests for drugs that require prior authorization.

MEDICAL ASSISTANCE HANDBOOK  
PRIOR AUTHORIZATION OF PHARMACEUTICAL SERVICES

**I. Requirements for Prior Authorization of Antivirals, Influenza**

**A. Prescriptions That Require Prior Authorization**

Prescriptions for Antivirals, Influenza that meet any of the following conditions must be prior authorized:

1. A non-preferred Antiviral, Influenza. See the Preferred Drug List (PDL) for the list of preferred Antivirals, Influenza at: <https://papdl.com/preferred-drug-list>.
2. An Antiviral, Influenza with a prescribed quantity that exceeds the quantity limit. The list of drugs that are subject to quantity limits, with accompanying quantity limits, is available at: <http://www.dhs.pa.gov/provider/pharmacyservices/quantitylimitslist/index.htm>.

**B. Review of Documentation for Medical Necessity**

In evaluating a request for prior authorization of a prescription for an Antiviral, Influenza, the determination of whether the requested prescription is medically necessary will take into account whether the beneficiary:

1. For a non-preferred Antiviral, Influenza, has a history of intolerance or contraindication of the preferred Antivirals, Influenza; **AND**
2. If a prescription for an Antiviral, Influenza is in a quantity that exceeds the quantity limit, the determination of whether the prescription is medically necessary will also take into account the guidelines set forth in the Quantity Limits Chapter.

NOTE: If the beneficiary does not meet the clinical review guidelines above but, in the professional judgement of the physician reviewer, the services are medically necessary to meet the medical needs of the beneficiary, the request for prior authorization will be approved.

**C. Clinical Review Process**

Prior authorization personnel will review the request for prior authorization and apply the clinical guidelines in Section B. above to assess the medical necessity of the request for a prescription for an Antiviral, Influenza. If the guidelines in Section B. are met, the reviewer will prior authorize the prescription. If the guidelines are not met, the prior authorization request will be referred to a physician reviewer for a medical necessity determination. Such a request for prior authorization will be approved when, in the professional judgment of the physician reviewer, the services are medically necessary to meet the medical needs of the beneficiary.

**D. 5-Day Supply**

The Department of Human Services does not consider the receipt of Xofluza (baloxavir) to be an emergency situation and therefore will NOT cover a 5-day supply of Xofluza (baloxavir) pending approval of a request for prior authorization.
