

## NTE Segment Changes Effective Date: 07/01/2022

In accordance with Bulletin OMHSAS-21-09 OMHSAS had expanded the NTE layout for Professional HealthChoices Behavioral Health encounters to allow the inclusion of an additional procedure code modifier **95** when the service is delivered in a Place of Service (POS) 02 (Telehealth) but done via telephone or audio only. However, effective 7/1/2022, this bulletin has been replaced with Bulletin OMHSAS-22-02.

OMHSAS-22-02 requires that modifier **FQ** replace modifier **95** for telephone audio only services effective for dates of service on or after 7/1/2022 and that modifier 95 be discontinued effective 6/30/2022. Also, Telehealth Place of Service codes have expanded as follows:

- 02 Telehealth Provided Other than in Patient's Home
- 10 Telehealth Provided in Patient's Home

The **Telehealth procedure code modifier** continues to be placed after the Evidence Based Programs and Practices (EBPP) subfields.

# INTRODUCTION

HIPAA 837 transaction sets include the optional use of NTE segments for the transmittal of free-form data. When used, the content of the NTE segments is based upon prescribed specifications known to both the submitter and receiver. Pennsylvania's Office of Mental Health and Substance Abuse Services (OMHSAS) has specified which data elements are to be included in NTE segments within all HealthChoices Behavioral Health encounters.

All encounters submitted to Pennsylvania PROMISe<sup>™</sup> must comply with the ASC X12 Technical Report Type 3 (TR3) standards, commonly referred to as "the Implementation Guides." The X12 standards specify acceptable placement of NTE segments within encounters. All HealthChoices Behavioral Health encounters must contain one or more NTE segments thereby assigning specific attributes to every service being reported. This requirement may be satisfied by a combination of one claim note (Loop 2300) and/or one or more-line notes (Loop 2400) in accordance with the Professional 837 TR3.

# **NTE SEGMENTS in ENCOUNTERS**

NTE segments can describe every service in an encounter. This can be accomplished with any one of the following

- a. One claim note (Loop 2300).
- b. One Line note for each service line (Loop 2400).
- c. One claim note and one or more line notes when a service line value overrides the claim note values.

#### NTE01 must be set to "ADD"

NTE02 must adhere to the layout noted below.

aa = Category of Aid

bb = Category of Service

- d = Value-Based Purchasing Indicator

gggggggggg = 13 digit MPI+Service Location of the DCO (if applicable).

hhh = First EBPP code (if applicable) For ICWC encounters only.

iii = Second EBPP code (if applicable) For ICWC encounters only.

jjj = Third EBPP code (if applicable) For ICWC encounters only.

kkk = Fourth EBPP code (if applicable) For ICWC encounters only.

lll = Fifth EBPP code (if applicable) For ICWC encounters only.

mm = Telehealth Procedure Code Modifier.

There is currently a limit of 5 Evidence Based Program & Practices (EBPP) codes for each service line. The highlighted fields are expected for Integrated Community Wellness Center (ICWC) encounters.

Effective with dates of service on or after 9/30/2021, OMHSAS had expanded the NTE layout for Professional HealthChoices Behavioral Health encounters to allow the inclusion of a Telehealth procedure code modifier **95** when the service is delivered in a Place of Service (POS) 02 (Telehealth) but done via telephone or audio only.

However, OMHSAS-22-02 now requires that modifier **FQ** replace modifier 95 for telephone audio only services effective with dates of service on or after 7/1/2022 and that modifier 95 be discontinued effective 6/30/2022. Also, Telehealth Place of Service codes have expanded as follows:

- 02 Telehealth Provided Other than in Patient's Home
- 10 Telehealth Provided in Patient's Home

This Telehealth procedure code modifier is very important for the Department's reporting as it will help demonstrate the need for a telephone or audio only option.

The Telehealth Procedure Code Modifier subfield has a length of 2 bytes and is placed after the EBPP subfields.

- Subfields cannot be compressed due to the occurrence of spaces or nulls. For example, the Value Based Purchasing Indicator must always occupy 1 byte.
- Trailing null values for situational subfields may be omitted along with its preceding vertical bar. See Correct Examples 4 through 7 below.
