### DHS Quarterly Licensing Report Quarter Two 2021 – April, May, and June 2021

The Department of Human Services licenses residential and day programs and services across five licensing offices – the Office of Child Development and Early Learning (OCDEL), the Office of Children, Youth, and Families (OCYF), the Office of Developmental Programs (ODP), the Office of Long-Term Living (OLTL), and the Office of Mental Health and Substance Abuse Services (OMHSAS). DHS and the Wolf administration are committed to upholding quality of care and services in licensed care settings, working with providers to address concerns and regulatory violations in a timely manner when identified, and holding providers accountable through provisional licenses and license revocations.

# **OMHSAS**

OMHSAS licenses a variety of mental health treatment services and supports for both adults and children. Services include both residential services such as Community Residential Rehabilitation (CRR) services, long term structured residences (LTSR) and residential treatment facility for adults (RTF-A) and non-residential services such as Outpatient Psychiatric Clinic, Partial Hospitalization, Psychiatric Rehabilitation services, among others. From April through June 2021, OMHSAS completed 403 annual inspections and 116 complaint inspections.
