DHS Quarterly Licensing Report Quarter Three 2021 – July, August, September 2021

The Department of Human Services licenses residential and day programs and services across five licensing offices – the Office of Child Development and Early Learning (OCDEL), the Office of Children, Youth, and Families (OCYF), the Office of Developmental Programs (ODP), the Office of Long-Term Living (OLTL), and the Office of Mental Health and Substance Abuse Services (OMHSAS). DHS and the Wolf administration are committed to upholding quality of care and services in licensed care settings, working with providers to address concerns and regulatory violations in a timely manner when identified, and holding providers accountable through provisional licenses and license revocations.

OCDEL

OCDEL certifies and oversees child care providers in licensed centers and home-based settings across Pennsylvania. From July through September 2021, OCDEL completed 1,169 annual inspections and 369 complaint investigations. OCDEL took action against five illegally operating, unlicensed providers in Allegheny, Cambria, Cumberland, Northampton, and Lancaster Counties.

OMHSAS licenses a variety of mental health treatment services and supports for both adults and children.
