





CHC Monthly Enrollment by Zone and MCO





> CHC March to April Market Share Changes








The NFI population continues to account for the majority of the population at 62.9%, representing a 0.2% decrease from last month. The percentage of HCBS participants increased by 0.1% to 26.6% and the LTC population increased by 0.1% to 10.5% of the population from March.


Statewide LTSS Population and HCBS Percentage






Medicare Type for All CHC Participants by Region**

In April, the statewide percentage of non-duals increased to 8.5% from 8.4%. The percentage of participants in aligned D-SNPs increased from 11.9% to 12.1%, and the percentage of participants in unaligned D-SNPs increased from 29.1% to 29.4%. The percentage of participants in FFS Medicare decreased by 0.4% to 38.7%. Other Medicare Advantage remained at 10.2%.



Medicare Type by CHC Zone and Plan




D-SNP participants have increased 16.6% since April 2020. The decrease in D-SNP enrollment for December is likely a data anomaly related to timing issues of when OLTL sends enrollment to CMS and when CMS sends D -SNP enrollment back, potentially due to open enrollment in Q4 2020. A mismatch between CMS and OLTL's IT systems would not count as a D-SNP enrollment for a particular plan. This will continue to be footnoted on future data briefs.




Number of Personal Care Homes and Assisted Living Facilities by County
