







# CHC March to April Market Share Changes








### CHC Enrollments by County\*


#### Statewide LTSS Population and HCBS Percentage



Medicare Type for All CHC Participants by Region\*\*



# Medicare Type by CHC Zone and Plan




#### D-SNP Enrollments by Plan




## Number of Personal Care Homes and Assisted Living Facilities by County
