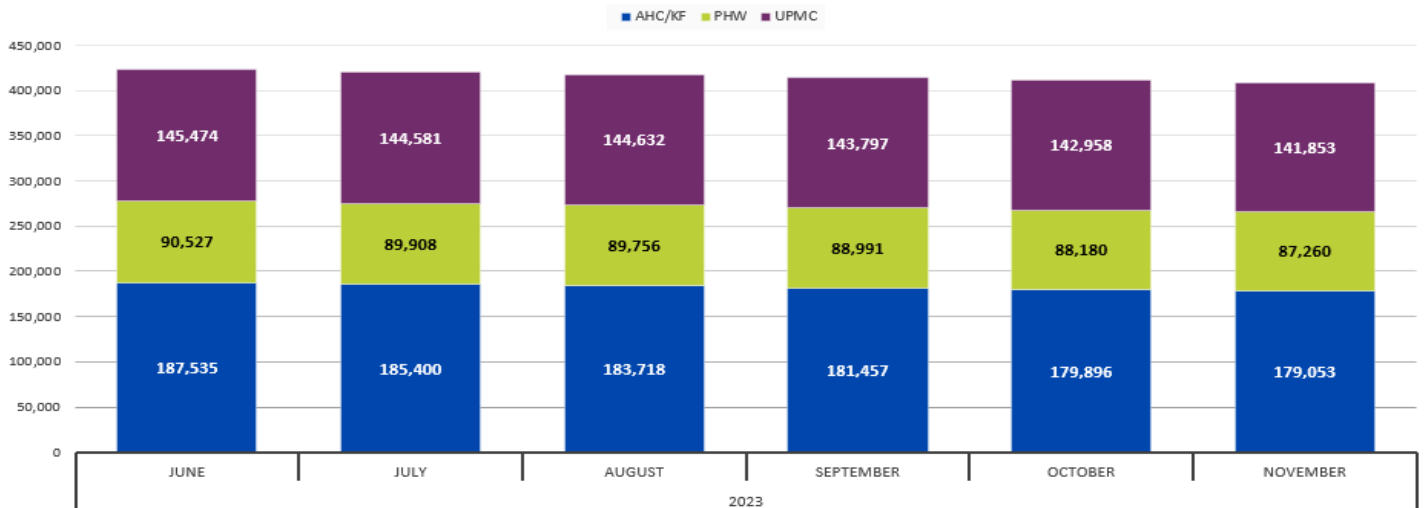

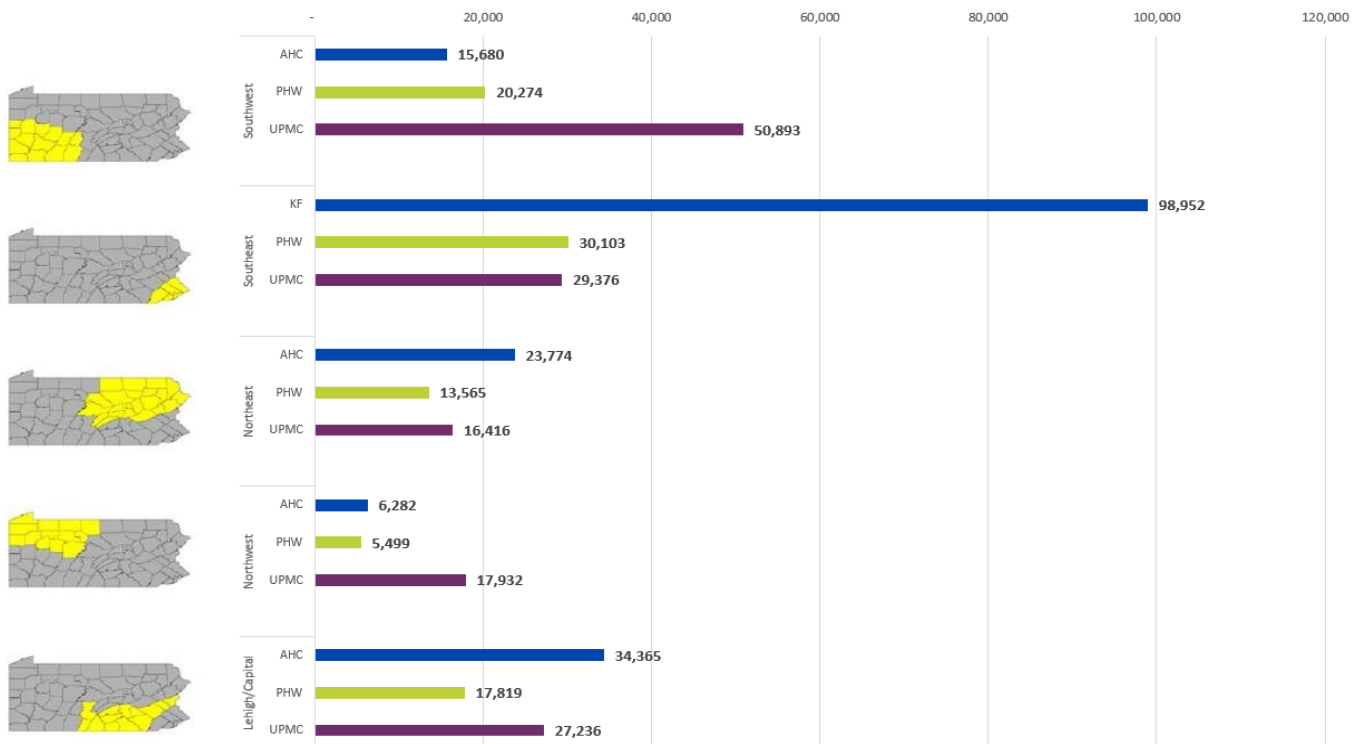
CHC Statewide Enrollments Trends by MCO

CHC Monthly Enrollment by Zone and MCO

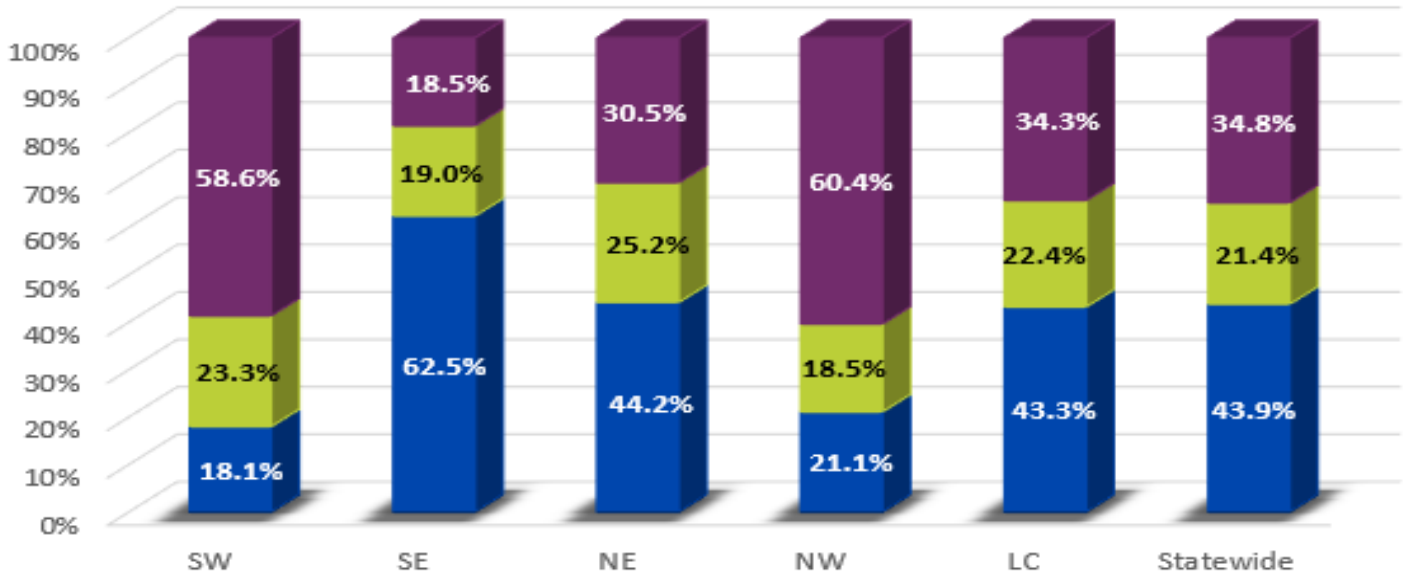

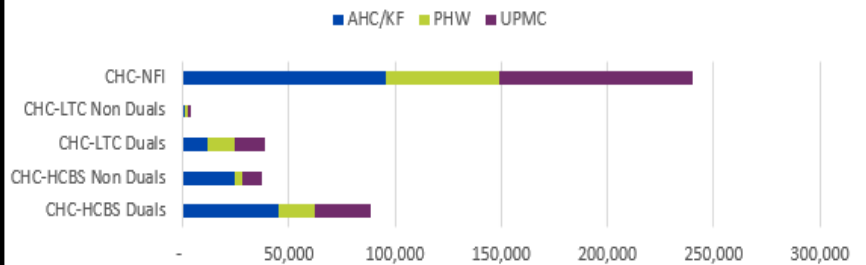

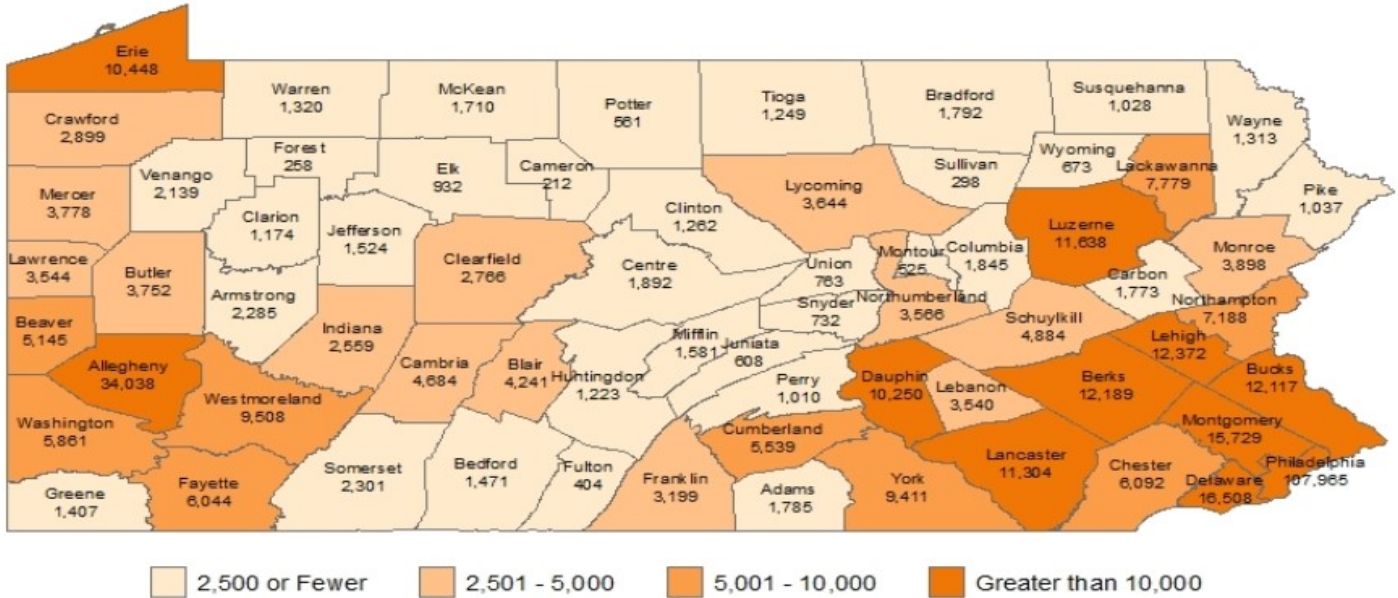

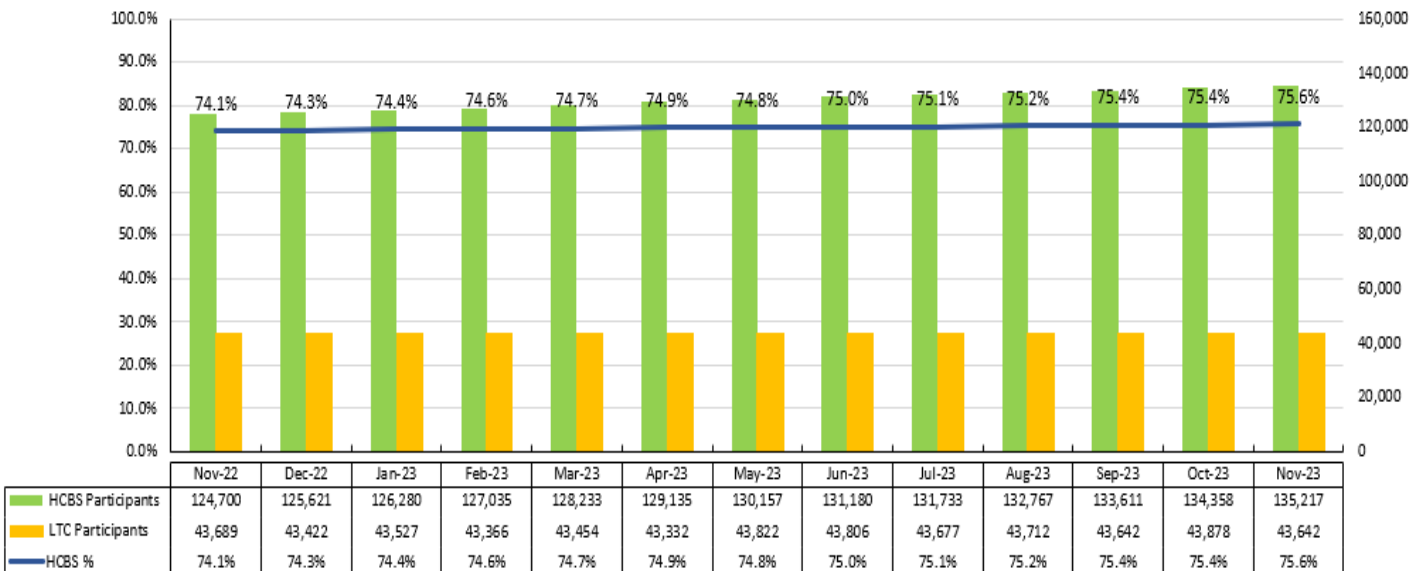

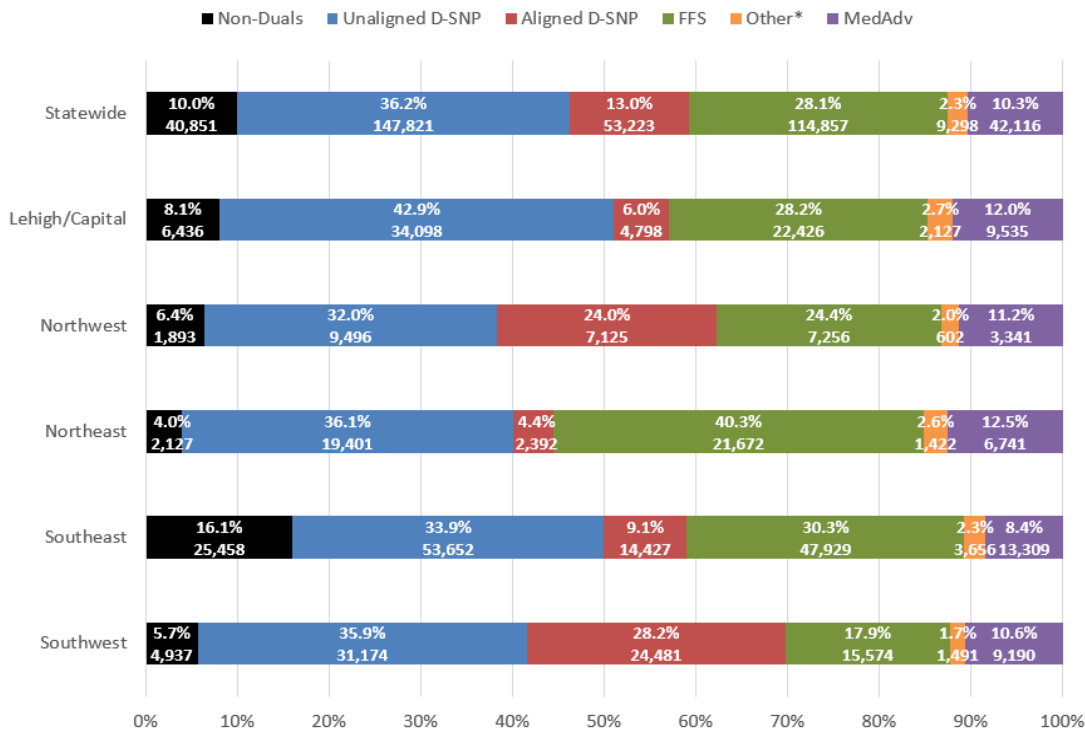
Statewide LTSS Populations Plus HCBS Percentage

Medicare Type for All CHC Participants by Region**

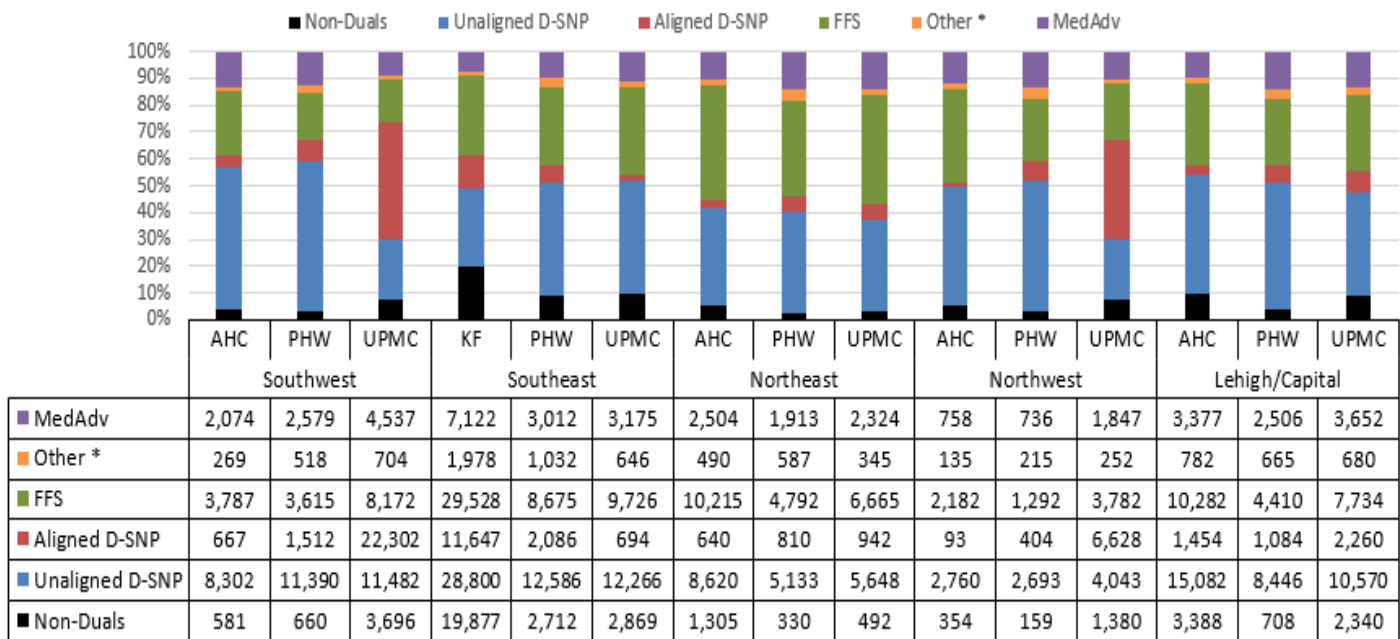


In November, the statewide percentage of non-duals increased from 9.9% to 10.0%. The percentage of participants in aligned D-SNPs decreased from 13.1% to 13.0%, and the percentage of participants in unaligned D-SNPs decreased from 36.7% to 36.2%. The percentage of participants in FFS Medicare remained the same at 28.1%. Other Medicare Advantage decreased from 10.7% to 10.3%. The Other category had percentage of participants increase from 1.6% to 2.3%.

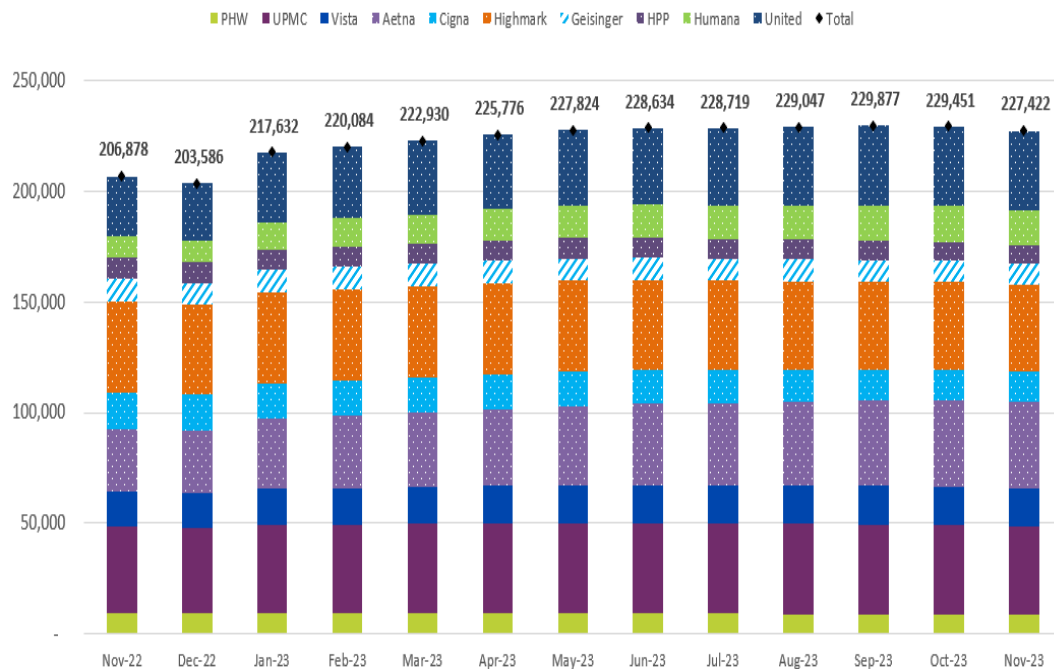

D-SNP Enrollments by Plan

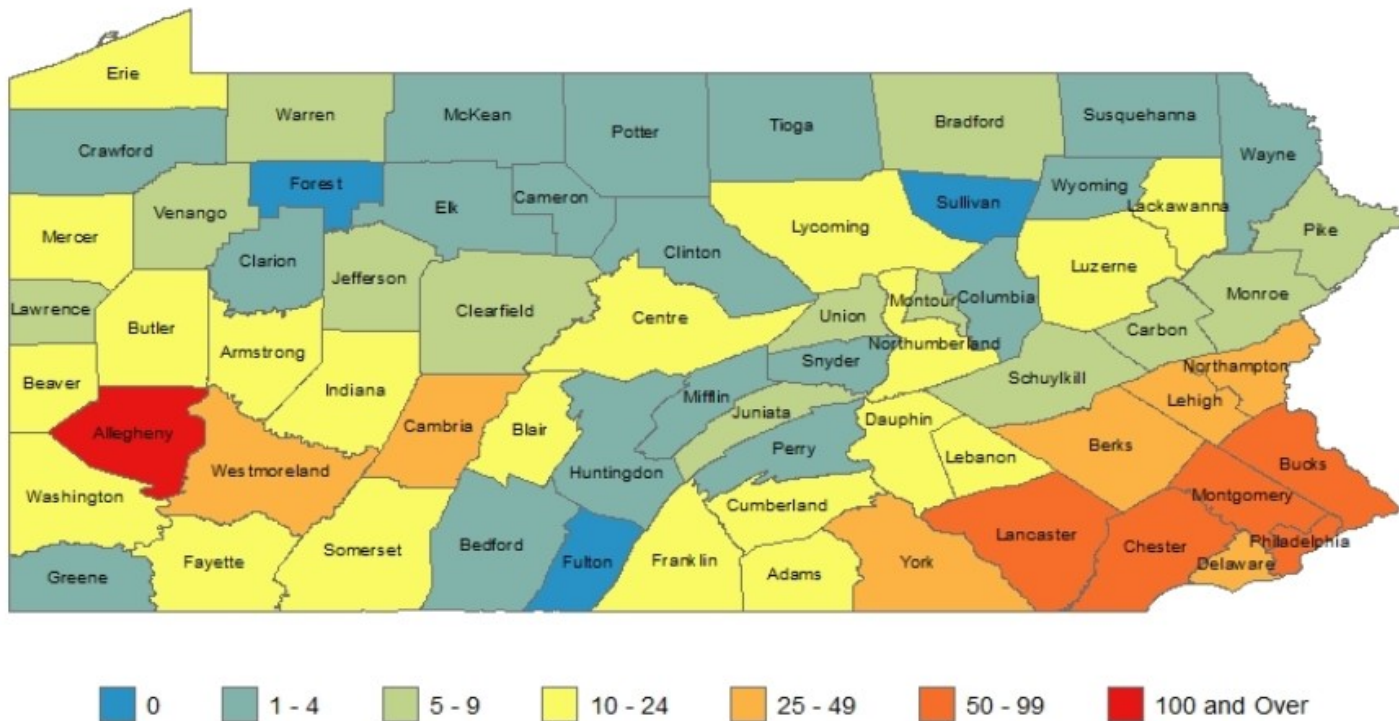


D-SNP participants have decreased 0.9% from October 2023 numbers. D-SNP Participants have seen a 9.9% increase between November 2022 and November 2023.

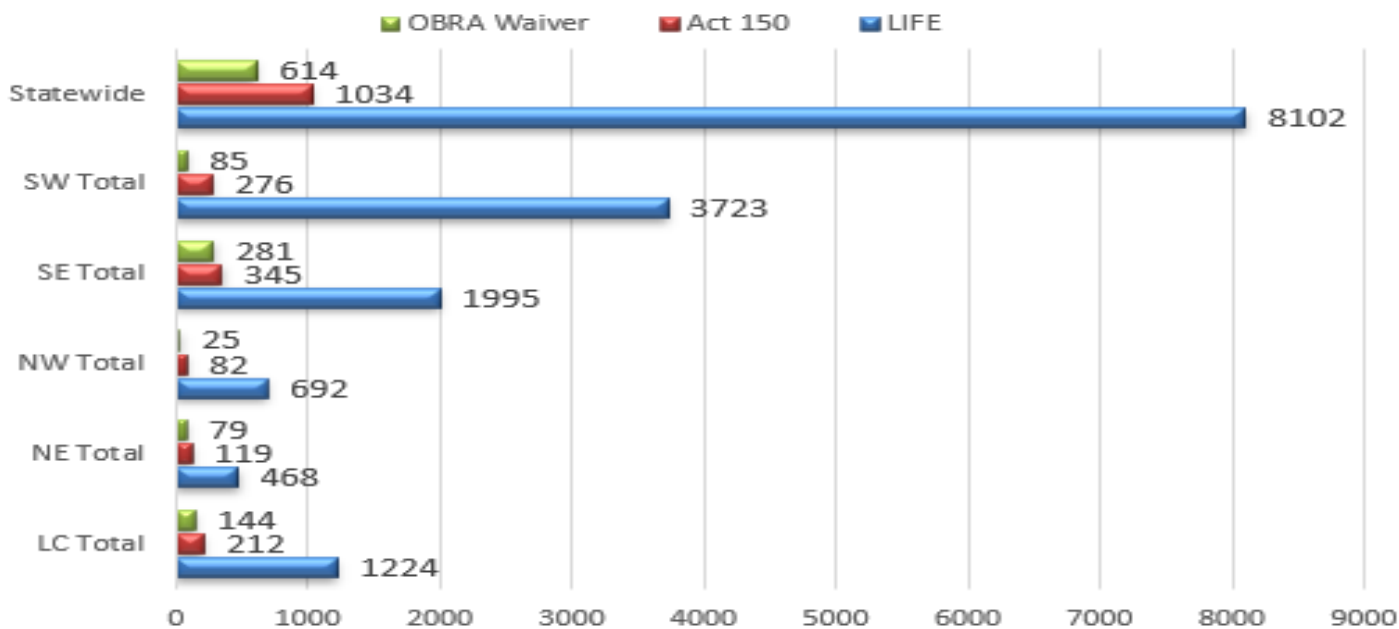

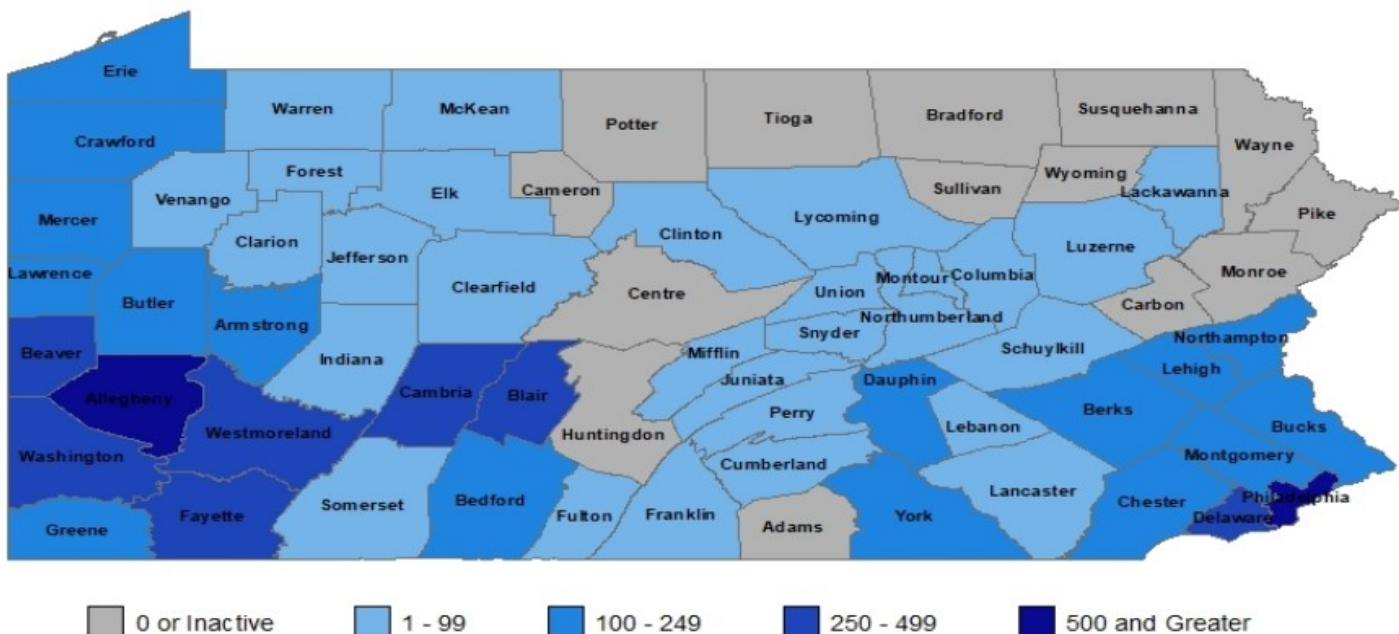
