**IMPORTANT REMINDER:** All providers must revalidate the Medical Assistance (MA) enrollment of each service location every 5 years. Providers should log into PROMISe to check the revalidation dates of each service location and submit revalidation applications at least 60 days prior to the revalidation dates. ### **PURPOSE:**

The purpose of this bulletin is to notify providers that the Department of Human Services (Department) will increase fees for private duty/shift nursing services provided to Medical Assistance (MA) beneficiaries under 21 years of age, effective with dates of service on and after January 1, 2022.

#### SCOPE:

This bulletin applies to providers enrolled in the MA Program who provide private duty/shift nursing services to MA beneficiaries under 21 years of age in the fee-for-service delivery system. Providers who render private duty/shift nursing services to MA beneficiaries under 21 years of age in the managed care delivery system should direct any fee-related questions to the appropriate managed care organization.

#### BACKGROUND/DISCUSSION:

In accordance with section 1729-B of the Fiscal Code (P.L. 343, No. 176), as amended by Act 24 of 2021, the Department will increase the MA Program Fee Schedule rate for private duty/shift nursing services provided to MA beneficiaries under 21 years of age by \$5.00 per hour. This fee increase will support continued access to these services by MA beneficiaries.

## PROCEDURE:

Effective with dates of services on and after January 1, 2022, the Department will increase the fees for private duty/shift nursing services to MA beneficiaries under 21 years of age as follows:

CPT Code	Description	Current MA Fee	MA Fee Effective January 1, 2022
S9123	Nursing care, in the home; by Registered Nurse, per hour	\$45.00	\$50.00
S9124	Nursing care, in the home; by Licensed Practical Nurse, per hour	\$45.00	\$50.00
