**IMPORTANT REMINDER:** All providers must revalidate the Medical Assistance (MA) enrollment of each service location every 5 years. Providers should log into PROMISe to check the revalidation dates of each service location and submit revalidation applications at least 60 days prior to the revalidation dates. ### **PURPOSE:**

The purpose of this bulletin is to issue updated handbook pages that include the requirements for prior authorization and the type of information needed to evaluate the medical necessity of prescriptions for Lipotropics, Statins submitted for prior authorization.

# **SCOPE:**

This bulletin applies to all licensed pharmacies and prescribers enrolled in the Medical Assistance (MA) Program. The guidelines to determine the medical necessity of Lipotropics, Statins will be utilized in the fee-for-service delivery system and by the MA managed care organizations (MCOs) in Physical Health HealthChoices and Community HealthChoices. Providers rendering services in the MA managed care delivery system should address any questions related to the prior authorization of Lipotropics, Statins to the appropriate MCO.

The Department of Human Services (Department) is updating the medical necessity guidelines for Lipotropics, Statins to remove the section related to automated prior authorization approvals and by revising the language in the guidelines for clarity and consistency. There are no other changes to the medical necessity guidelines.

The revisions to the guidelines to determine medical necessity of prescriptions for Lipotropics, Statins were subject to public review and comment and subsequently approved for implementation by the Department.

### **PROCEDURE:**

The procedures for prescribers to request prior authorization of Lipotropics, Statins are located in SECTION I of the Prior Authorization of Pharmaceutical Services Handbook. The Department will take into account the elements specified in the clinical review guidelines (which are included in the provider handbook pages in the SECTION II chapter related to Lipotropics, Statins) when reviewing the prior authorization request to determine medical necessity.

As set forth in 55 Pa. Code § 1101.67(a), the procedures described in the handbook pages must be followed to ensure appropriate and timely processing of prior authorization requests for drugs and products that require prior authorization.

# MEDICAL ASSISTANCE HANDBOOK PRIOR AUTHORIZATION OF PHARMACEUTICAL SERVICES

## I. Requirements for Prior Authorization of Lipotropics, Statins

# A. <u>Prescriptions That Require Prior Authorization</u>

Prescriptions for Lipotropics, Statins that meet any of the following conditions must be prior authorized:

- 1. A non-preferred Lipotropic, Statin. See the Preferred Drug List (PDL) for the list of preferred Lipotropics, Statins at: <a href="https://papdl.com/preferred-drug-list">https://papdl.com/preferred-drug-list</a>.
- A Lipotropic, Statin with a prescribed quantity that exceeds the quantity limit. - 3. A Lipotropic, Statin when there is a record of a recent paid claim for another Lipotropic, Statin in the Point-of-Sale On-Line Claims Adjudication System (therapeutic duplication).

### B. Review of Documentation for Medical Necessity

In evaluating a request for prior authorization of a prescription for a Lipotropic, Statin the determination of whether the requested prescription is medically necessary will take into account whether the beneficiary:

- 1. For a non-preferred Lipotropic, Statin, has a history of therapeutic failure of or a contraindication or an intolerance to the preferred Lipotropics, Statins; **AND**
- 2. For the rapeutic duplication, **one** of the following:
  - a. Is being transitioned to or from another Lipotropic, Statin with the intent of discontinuing one of the medications
  - b. Has a medical reason for concomitant use of the requested medications that is supported by peer-reviewed medical literature or national treatment guidelines;

#### AND

3. If a prescription for a Lipotropic, Statin is for a quantity that exceeds the quantity limit, the determination of whether the prescription is medically necessary will also take into account the guidelines set forth in the Quantity Limits Chapter.

NOTE: If the beneficiary does not meet the clinical review guidelines listed above but, in the professional judgment of the physician reviewer, the services are medically necessary to meet the medical needs of the beneficiary, the request for prior authorization will be approved.

### C. Clinical Review Process

# MEDICAL ASSISTANCE HANDBOOK PRIOR AUTHORIZATION OF PHARMACEUTICAL SERVICES

Prior authorization personnel will review the request for prior authorization and apply the clinical guidelines in Section B. above to assess the medical necessity of a prescription for a Lipotropic, Statin. If the guidelines in Section B. are met, the reviewer will prior authorize the prescription. If the guidelines are not met, the prior authorization request will be referred to a physician reviewer for a medical necessity determination. Such a request for prior authorization will be approved when, in the professional judgment of the physician reviewer, the services are medically necessary to meet the medical needs of the beneficiary.
