# PURPOSE:

The purposes of this annuoncement are to:

- To introduce the mandated Federal training requirements in health and safety that child care providers must complete. See Attachment 1.
- To advise providers that, beginning July 1, 2016, <u>nine topics of the Federal training requirements</u> will be available in one six-hour, online course available at: <u>http://extension.psu.edu/youth/betterkidcare/on-demand</u> or be taken in-person by contacting the Regional Key. The name of the course is: *Health and Safety Basics: Requirements for Certification.* The six-hour module is <u>free of charge</u> and includes up-to-date medically-approved content regarding children's health and safety.
- To advise that the Federal training topics not included on the six-hour module must be taken separately.
- To inform providers that taking the *Health and Safety Basics* module will count toward the mandatory six-hour annual professional development requirement as stated in §§ 3270.31(e), 3280.31(e) and 3290.31(f).
- To advise providers how to determine whether some or all of the health and safety training already taken by staff persons since September 30, 2014 may meet the Federal training requirements.
- To advise providers that all staff persons should meet the Federal training requirements by September 30, 2017.

# BACKGROUND:

The Federal Administration of Children and Families issued The Child Care and Development Block Grant (CCDBG) requirements for states to implement with child care providers by September 30, 2016. Part of those requirements included specific training topics that must be taken by all child care staff in certified facilities. The <u>10</u> Federal training topics are all related to the health and safety of children in care. The Federal training topics are very similar to the acceptable training topics as stated in the current certification regulations in §§ 3270.31(e)(2), 3280.31(e)(2) and 3290.31(f)(2) which also are related to the health and safety of children in care.

The Office of Child Development and Early Learning (OCDEL) is in the process of revising the existing regulations in §§ 3270, 3280 and 3290 to further clarify that all child care staff must take the Federal training topics in addition to, or as a part of, the annual requirement for training as specified in §§ 3270.31(e), 3280.31(e) and 3290.31(f).

### DISCUSSION:

OCDEL recognizes that meeting the Federal training topic requirements will require certified providers to plan carefully to assure that all staff persons meet the Federal mandate, as well as state certification requirements that each staff person obtains six hours of training annually.

OCDEL recognizes also that child care providers must have internal tracking systems to document that the current staff persons have completed the Federal training topics as well as completing the annual six-hour training requirement as per the current regulations.

Of the 10 Federal training topics, nine are included in the six-hour module that is available online or inperson. The 10<sup>th</sup> topic, Cardiopulmonary Resuscitation (CPR) training / First-Aid training, cannot be offered online and must be taken in-person.

For the CPR training, the provider must assure that there is a minimum of one staff person available at all times who has been trained in CPR.

For the First-Aid training, there is already a requirement in §§ 3270.31(e)(4)(i), 3280.(e)(4)(i) and 3290.31.(f)(4)(i) that an appropriate staff person complete First-Aid training.

Providers can assure that staff meet the new Federal requirements by:

- Taking the six-hour module with the nine topics that is now available from Better Kid Care at <u>http://extension.psu.edu/youth/betterkidcare/on-demand</u> or in-person training provided by the Regional Key; or
- Assessing the training topics that staff has taken since September 30, 2014 to determine if the course the staff person already completed is equivalent to one or more of the nine topics; and
- Assuring that appropriate staff persons are trained in CPR and First-Aid.

#### **Six-hour training Module**

The Bureau of Certification and the Bureau of Early Learning Services of the Office of Child Development and Early Learning (OCDEL) have directed the development of the six-hour training modules, which cover nine topics.

- These modules are now available for new child care providers as a part of their orientation to become a certified child care provider.
- These modules are also available now for existing child care staff to take to meet the six-hour annual training requirement as prescribed for topics under "training topics" in §§ 3270.31(e)(2) 3280.31(e)(2) and 3290.31(f)(2).

The online modules of the nine topics are available at:

http://extension.psu.edu/youth/betterkidcare/on-demand. The title is: *Health and Safety Basics: Requirements for Certification* 

The in-person training for the nine topics consists of two three-hour training sessions and is available by scheduling the training with the Regional Key. The title is: *Health and Safety Basics: Requirements for Certification*. See Attachment 2 (Regional Key map.)

This training is **free of charge** to all child care staff. Once the staff person has completed the training, the person will receive a certificate of completion that serves as documentation that the staff person has taken the training.

By having the current child care staff persons take the nine topics in the six-hour modules and assuring that the CPR and First-Aid training is documented as complete:

- Providers will have opportunities to revise and/or restructure their documentation systems to show that staff have met the Federal requirements; and
- Providers can better schedule staff to take the federally-mandated training that also meets the annual six-hour requirement for in §§ 3270.31(e)(2), 3280.31(e)(2) and 3290.31(f)(2).
- Providers can determine which staff persons must be trained in CPR and First-Aid.

#### Assessing training topics already taken by staff

OCDEL is also aware that within the past two years many child care staff persons have taken or are in the process of taking training sessions that include the content of the material in the Federal training topics listed in Attachment 1. If staff persons have taken equivalent courses covering some or all of Federal training topics since September 30, 2014, those sessions can count towards meeting the Federal requirement. In order for child care providers to be able to use the courses taken by any staff person since September 30, 2014 which may meet the Federal requirement, child care providers must provide documentation for the Bureau of Certification to evaluate. There are two ways that the child care provider can document that the staff person has already taken some or all of the Federal training topics:

- If the staff person has used the Professional Development (PD) Registry, the child care provider can access the PD Registry and obtain the information about each staff person's history of taking any training that corresponds to the Federal training topics. The child care providers can then record the training topic for each staff person on the form in Attachment 3. The child care providers can access the information provided by the PA Key at www.pakeys.org to see which courses are equivalent to the Federal training topics. The child care providers can then determine what additional training each staff person needs to meet all of the Federal requirements
- If the staff person has not used the PD Registry but has taken courses which include the Federal training topics, the child care provider must provide separate and detailed documentation that the content of the course meets the Federal training topics. The child care provider shall place the documentation in the staff person's file.

#### **Bureau of Certification Review**

Starting September 30, 2016, the certification representative will, at the annual renewal inspection, review any documentation that the child care provider has regarding each staff person's progress in taking the Federal training topics. If the child care provider does not have documentation for each staff person, then the certification representative will have a discussion with the operator regarding the plans that the operator has for existing staff to meet the Federal training topics requirement by September 30, 2017. The intent of the discussion is to assure that the child care provider has a process in place to meet the Federal requirements and to direct the operator to any resources available regarding the Federal training topics, specifically, the six-hour training module available at: <a href="http://extension.psu.edu/youth/betterkidcare/on-demand">http://extension.psu.edu/youth/betterkidcare/on-demand</a> or the in-person training provided by the Regional Key.

## NEXT STEPS:

Child care providers should:

- 1. Read this Announcement
- 2. Make sure staff understand that they can take the six-hour module offered beginning July 1, 2016, to meet the annual six-hour training requirement and also meet the Federal requirements.
- 3. Determine which staff persons will be required to take CPR/First-Aid training.
- 4. Review the training documentation systems to be sure that the system reflects staff completion of required training for the Federal and state requirements.

5. Review training records of staff to determine if any staff person has already taken the required Federal training topics in the past two years and assure that the information is in the child care provider's training documentation system and the staff person's file.

Staff and Business Partners should:

- 1. Review this Announcement
- 2. Talk to providers about the importance of completing the Federal training requirements.
- 3. Direct providers to the resource available to complete all of the required topics: <u>http://extension.psu.edu/youth/betterkidcare/on-demand</u> or by contacting the Regional Key.
- 4. Direct questions to the supervisor or regional director.
