

**Healthcare-associated Infections (HAI) Surcharge,  
Medical Assistance (MA) Pass-through Payments  
(for MA-11 Cost Reports with Acceptance Letters mailed on or before October 19, 2020)**

The Department of Health’s annual healthcare associated infection (HAI) surcharge on a nursing facility’s licensing fee is an allowable cost under the MA Program. The MA portion of the HAI surcharge will be reimbursed as a pass-through payment and will be paid on an annual basis. A nursing facility’s annual HAI pass-through payment will equal the annual HAI surcharge fee paid by the nursing facility, less any penalties assessed, as verified by the DOH, multiplied by the nursing facility’s MA occupancy rate as reported on the nursing facility’s MA-11 cost report for the year in which the annual HAI surcharge is paid.
