## Ordering/Prescribing Services through the Medical Provider Authorization Form (MPAF)

All health-related services provided pursuant to an IEP/IFSP and billed through the SBAP must first be ordered/prescribed by an appropriate provider. The chart below indicates which provider types may sign for all service types allowed within SBAP and which provider types have more limited authority. As an example, if a student has social work and nursing services listed as related services in the IEP, while the licensed social worker may sign the MPAF ordering/prescribing their own services, the IEP must be reviewed and MPAF signed by a second provider with the authority to prescribe the nursing services.
