### Abstract:

This Information Technology Policy (ITP) establishes policy for the development of accessible websites for users requiring assistive technologies.

The goal of this policy is to ensure that when an agency, board or commission provides information through the web, it is taking reasonable measures to ensure that persons with disabilities can access, navigate, and otherwise obtain the same or equivalent information as those persons without disabilities.

### General:

This ITP applies to all departments, boards, commissions and councils under the Governor's jurisdiction (Agencies). Agencies not under the Governor's jurisdiction are strongly encouraged to follow this policy.

# Policy:

This policy establishes standards for the development and maintenance of accessible websites. For purposes of this policy, "website" is defined as any content or application accessed through an Internet browser. Agencies developing websites are to (1) provide the same or equivalent access to qualified individuals with disabilities and (2) test and validate websites.

Agencies are to test and validate websites using one or more of the following methods in conjunction with end user assistive technologies:

- 1.) Accessibility testing and validation features of Integrated Development Environment (IDE).
- 2.) Automated validation tools named as product standards in *STD-ACC001A Accessibility Product Standards*.
- 3.) OPD-ACC001C, AccVerify Accessibility Rule Settings
- 4.) Manual testing and validation.
