Abstract:

A protocol is an agreed upon format for interaction at the computer as well as the human level. A protocol stack is a series of protocols arranged in layers, each layer performing a single, well-defined function, with clearly delineated interfaces, which permit functional replacement at a layer-by-layer level.

General:

The Health and Human Services Delivery Center (HHS DC) supports the Departments of Health (DOH), Human Services (DHS), Aging (PDA), Drug and Alcohol Programs (DDAP) and Military and Veterans Affairs (DMVA).

The purpose of this document is to announce the network protocol determined by the Network Unit and in place at the Health and Human Services Delivery Center (HHS DC) Technology Services Office (TSO).

Standard:

TCP/IP

For the network, HHS DC TSO selected the Transmission Control Protocol/Internet Protocol (TCP/IP) protocol stack originally developed during the late 1960s through research funded by the Defense Advanced Research Projects Agency (DARPA).

TCP/IP provides a common transport environment between disparate computer systems, a common set of tools and utilities (for terminal access, file transfer, electronic mail, and network management), and a

standard mechanism for inter-process communication.
