Abstract:

A protocol is an agreed upon format for interaction at the computer as well as the human level. A metropolitan area network (MAN) is a network created by connecting two or more local area networks (LANs).

General:

The Health and Human Services Delivery Center (HHS DC) supports the Departments of Health (DOH), Human Services (DHS), Aging (PDA), Drug and Alcohol Programs (DDAP) and Military and Veterans Affairs (DMVA).

The purpose of this document is to announce the MAN protocols and wiring determined by the Network and Telcom Units and in place at the Health and Human Services Delivery Center (HHS DC) Technology Services Office (TSO).

Standard:

HHS DC's standard method for connecting LANs within a metropolitan area is the Multi-Protocol Label Switching (MPLS) protocol.
