Medical Assistance Health Information Technology Initiative Electronic Health Record Incentive Program

The Pennsylvania Medical Assistance (MA) Electronic Health Record (EHR) Incentive Program is now available to Eligible Professionals (EPs) and Eligible Hospitals (EHs.) The MA EHR Incentive Payment Program provides funding to states to encourage providers to adopt EHRs and move toward meaningful use of those EHRs.

All EPs and EHs intending to apply for the incentive program must be enrolled in Pennsylvania's MA Program. To enroll, please complete the application for your provider type, which can be found at: http://www.dhs.pa.gov/provider/promise/enrollmentinformation/S_001994.

In order to participate, enrolled MA providers also need to set up an account for the PROMISE™ internet portal at: <http://promise.dpw.state.pa.us>.

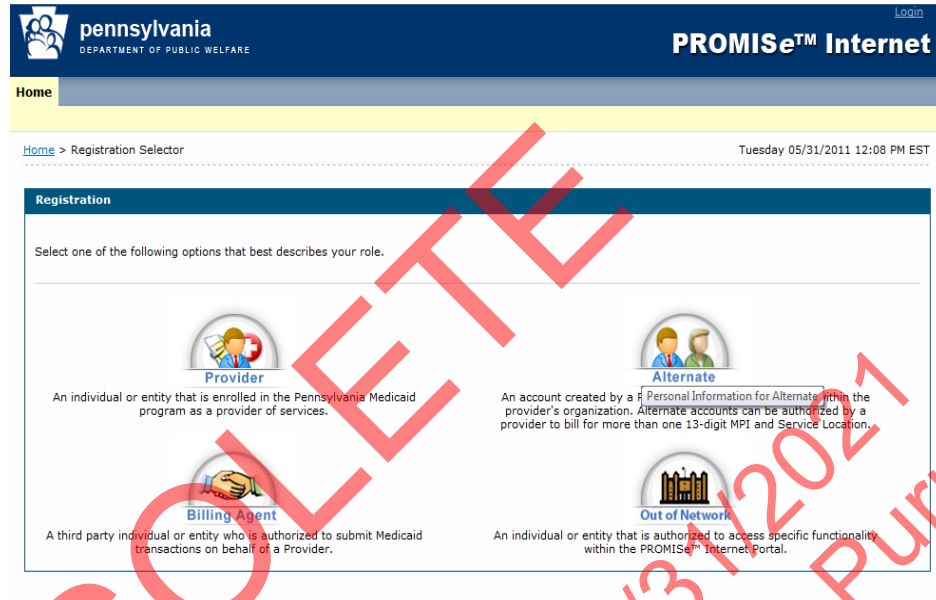

REGISTRATION WITH CMS. EPs and EHs in Pennsylvania must first register through the [Centers for Medicare & Medicaid \(CMS\) Registration & Attestation System](#)

REGISTRATION ON THE DEPARTMENT OF Human Services' (DHS's) MA PROVIDER INCENTIVE REGISTRY (MAPIR) SYSTEM. Once registered with CMS, the applicant will be notified via an email that will be sent to the email address that was submitted during the registration process with CMS indicating they can begin the registration process through Pennsylvania's MAPIR System. After receiving the notification, applicants can begin the registration process. DHS has EP and EH Provider manuals that will serve as guides to Pennsylvania's registration process. CMS EHR CERTIFICATION NUMBER. You will need to have a CMS EHR Certification Number prior to applying for the MA EHR incentive program. In order to obtain this number, visit the Office of the National Coordinator for Health Information Technology (HIT) [\(ONC\) website](#) and follow the steps.

- a. Verify eligibility based on provider type
- b. Verify MA volume requirements
- c. Verify **PROMISE™** provider information is current and accurate (verify TIN, NPI, Provider type)
- d. Verify your CMS EHR Certification ID number
