## State Program

- Designed a Refugee Cash and Medical Assistance Training that was approved and implemented by internal Staff Development. Training on RCA/RMA was provided to multiple County Assistance Office staff across the state.
- Provided open lines of communication to CAOs to clarify ORR policy including immigration and welfare benefits eligibility.
- Updated the Refugee Guidelines that detail all programmatic activities (last published in 2013). Statewide training to begin in FFY2018.
- Established and met with the Refugee Advisory Council.
- Redesigned the <u>www.refugeesinpa.org</u> website. Approval forthcoming.
- Created a new reporting mechanism for "one-click" monthly and annual contractor reports. Currently in beta testing phase.
- Coordinated a successful showing of After Spring, a film about life in a Jordanian refugee camp.
- Successfully moved the Unaccompanied Refugee Minors program to Bethany Christian Services after the closing of Lutheran Children and Family Service.
- Hired a new State Refugee Health Coordinator to oversee and manage refugee health activities.

- Re-established collaboration between the state's Bureau of Emergency Preparedness to represent the interests of refugees, in particular to address cultural and linguistics differences.
- Ongoing partnerships with several community organizations to expand capacity in refugee health.
- Attendance and participation in numerous summits, conferences, and meetings that focused on employment services, English language training, health, and access to mainstream programs.
- Made successful contact with the Department of Aging to attain greater understanding of services to our elderly population.
- Provided increased case management support to resettlement workers looking for solutions to working with those who suffer from complex medical/mental health issues.
- Coordinated multiple Mental Health First Aid Trainings across the state in both Bhutanese and English.
- Sought to increase knowledge, establish interagency partnerships, and provide prevention funding for refugees suffering from substance abuse, treat lead-poisoning, latent TB, and a host of other medical-attention needs.
- Continued to fund 47 refugee programs with a wide variety of services from employment and job skills training, medical/mental health screening, elderly and youth involvement, urban grow projects, Nepali to American sign language classes, driving instruction, interpretation/translation, civic engagement, citizenship services, and many others.
- Always looking for new and innovative ways to serve refugees!
